## 31 REPORT OF THE BEREAVEMENT SERVICES MANAGER

### 4.1 Christmas Carol Service

The Bereavement Services Manager informed Members that regrettably due to the Pandemic and current restrictions it is not possible to hold the annual Christmas Service at the Crematorium this year. However, a local branch of Dignity Funerals approached the Crematorium to ask they could jointly hold a virtual Christmas Concert at the Crematorium on Saturday 12<sup>th</sup> December 2020 at 12 noon, to which the Committee had agreed.

### 4.2 Statistics and Performance

In her report, the Bereavement Services Manager provided Members with Statistics and Performance figures relating to the operation of the Crematorium since the last meeting.
