#### 63 APPLICATION RECOMMENDED FOR APPROVAL

# Application No.14/0937 – New Play Area – Ynysangharad War Memorial Park, Pontypridd

Set out in the report of the Service Director, Planning were details of the above-mentioned application which was recommended for approval subject to conditions.

Non-Committee Member – County Borough Councillor A.Crimmings addressed the Committee on the application.

Following consideration of the proposal, it was **RESOLVED** to approve the application in accordance with the recommendation of the Service Director, Planning.

# 64 <u>APPLICATIONS RECOMMENDED FOR APPROVAL INVOLVING PUBLIC SPEAKERS</u>

(1) Application No.13/0699 – Installation of ground mounted photovoltaic (PV) solar arrays to provide 11.6 MW generation capacity together with transformer stations; internal access track; landscaping; fencing; security measures; access gate and ancillary infrastructure (cross boundary application with Neath Port Talbot) – Hendrefawr, Mount Road, Rhigos, Aberdare

In accordance with adopted procedures, the Committee received Mr.D.Dean (Applicant), who was afforded up to five minutes to address the Committee.

The Service Director, Planning outlined the proposal and following a discussion, it was **RESOLVED** to approve the application in accordance with the recommendation of the Service Director, Planning.

# (2) Application No.14444/0578 – 6 no. Link houses – Site of Old Bingo Club and Snooker Rooms, Station Road, Treorchy

In accordance with adopted procedures, the Committee received Mr.M.Gilheaney (Applicant), who was afforded up to five minutes to address the Committee.

In his report, the Service Director, Planning outlined the application which was recommended for approval subject to conditions and the applicant entering into a Section 106 agreement to make a transport tariff contribution towards improving the strategic highway network.

The Development Control Manager reported orally on the contents of "late" correspondence received from the Applicant requesting that his application be deferred to allow the issue of the transport tariff to be resolved owing to the submission of evidence by his Highways & Transportation Consultants to show the proposed development of 6 houses would result in a significant reduction in traffic generation when compared to the permitted use of the land for 18 flats.

Following consideration of the proposal, it was **RESOLVED** to approve the application in accordance with the recommendation of the Service Director, Planning subject to the applicant entering into a Section 106 agreement to make a transport tariff contribution towards improving the strategic highway network at a rate of:

Residential 3/4/5 + bedrooms at £3,008 / unit x 50% Level 3 tariff - £9024

With regard to the timing of payment, 25% would be payable upon commencement of development, 50% upon the completion of 50% of the development and the remaining 25% upon the completion of 75% of the development.

# 65 <u>DEFERRED APPLICATION INVOLVING PUBLIC SPEAKERS</u>

# Application No.13/0890/10 – New Mobile Home – Land North of Gellifendigaid Transmitter, Coed y Cwm, Ynysybwl

With reference to Minute No.218(2) (Development Control Committee, 3 April 2014) the Service Director, Planning reported that the applicant had now submitted a Planning Appraisal for an Agricultural Workers Dwelling at the site and his assessment of the proposal, incorporating the Planning Appraisal, was outlined in his report for the Committee's consideration.

The Development Control Manager reported orally on the contents of a "late" letter received from the applicant providing additional information in relation to the agricultural assessment in relation to trees and other areas that were missing from the original Planning Appraisal submitted. In view of the lateness of receiving this additional information, the Development Control Manager strongly recommended that the Committee consider deferring the application to allow Officers the opportunity to assess the new information provided by the applicant.

It was **RESOLVED** in accordance with the Officer's oral recommendation, to defer the application to assess the additional information provided by the applicant.

#### 66 SITE INSPECTION

Application No.13/0376 – Erection of a Bungalow (amended plans received 04/07/14) – Land adjacent to No.14 Caemawr Terrace, Penrhiwfer

In accordance with Minute No.46(2) (Development Control Committee, 7 August 2014), the Director, Legal & Democratic Services reported on the outcome of a site inspection undertaken by Committee Members on 18 August 2014 to consider the site of the proposed dwelling in relation to the settlement boundary. The application detail was set out in Appendix 1 to

the report and was recommended for refusal for the reasons listed by the Service Director, Planning.

Following consideration of the proposal, it was **RESOLVED** to refuse the application in accordance with the recommendation of the Service Director, Planning.
