## Rhondda Cynon Taf County Borough Council Development Control Enforcement – Delegated decisions March 2015

---

### **EN/13/00125**

Location: The Potting Shed, Llantrisant  
Breach: The inclusion of a retail shop (homewares) and cafe to the existing timber merchants

Decision: Enforcement Notice (to cease the retail shop and cafe)

Reason: 1. The retail and cafe uses are contrary to Policy AW 2 of the Rhondda Cynon Taf Local Development Plan in that they represent development in an unsustainable location. They are contrary to Policy AW5 of the Rhondda Cynon Taf Local Development Plan in that the development is not accessible to the local and wider community by a range of sustainable modes of transport, and they are contrary to Policy AW11 of the Rhondda Cynon Taf Local Development Plan in that there is a lack of marketing of the employment land for its established use.

2. The retail and cafe uses are contrary to Paragraph 10.3.1 of Planning Policy Wales as they are considered to be best located in a town centre. There is no evidence which has been submitted of a sequential approach to site selection for the retail and cafe uses.
