**1. PURPOSE OF THE REPORT**

The purpose of this report is to propose arrangements for Scrutiny to progress the Notice of Motion in respect of Community Snow Wardens supported by Full Council held on the 19th September 2018.

**2. RECOMMENDATIONS**

It is recommended that Scrutiny:

- 2.1 Establish a Working Group to consider the content of this Motion
- 2.2 Subject to 2.1 above, the Working Group to receive a report from the Director of Highways & Streetcare Services at its inaugural meeting, outlining how this policy could be implemented.

**3. REASONS FOR RECOMMENDATIONS**

- 3.1 To take forward the decision of Full Council taken on the 19<sup>th</sup> of September 2018 and make subsequent recommendations for implementation of this policy.

**4. BACKGROUND**

- 4.1 On the 19th September 2018, Full Council considered a Motion in respect of establishing Voluntary Community Snow Wardens. The following Notice of Motion was recorded:

Notice of Motion standing in the names of County Borough Councillors P.Jarman, S.Rees-Owen, G.R.Davies, M.Weaver, E.Webster, D.Grehan, H.Fychan, D.Macey, A.Cox, J.Williams, K.Morgan, J.Davies, J.Cullwick, E.Stephens, L.Jones, A.Chapman and S.Evans was considered:

“That this Council, as part of its emergency planning responsibilities introduces a scheme of voluntary Snow Wardens to assist in snow clearance in the community during heavy snowfall. The snow wardens will be registered with the Council and be properly trained and equipped to undertake snow clearance in their locality.”

- 4.2 Following discussions it was resolved to refer the Notice of Motion to the Public Service Delivery, Communities and Prosperity Scrutiny Committee.
- 4.3 It was also acknowledged by the Council that it is important for this decision to be expedited swiftly to allow the opportunity for these proposed new arrangements to be included as part of the Council’s wider Severe Winter Weather preparations.
- 4.4 It is proposed to utilise previously established working practices to progress this matter, through the establishment of a Working Group. The Proposer and Seconder of the amendment will be invited to participate in this Working Group.
- 4.5 As a consequence of the need to progress this matter swiftly, it is proposed that this Working Group receive a report from the relevant Director that outlines options to progress the decision of the Council at its first meeting. Any final recommendations made by the Committee will be referred to the Cabinet to agree specific implementation arrangements, arising from the findings of the Working Group.
