ATODLEN 1 – Gwahardd Aros ar Unrhyw Adeg

1. Danybryn, Brynsadler

- a. Yr ochr orllewinol, o'i chyffordd â Heol Llanhari tua'r gogledd am bellter o tua 41 metr.
- b. Yr ochr ddwyreiniol, o bwynt sydd gyferbyn â ffin gyffredin rhifau 46 a 47 tua'r de am bellter o tua 13.5 metr.
- c. Yr ochr ddwyreiniol, o bwynt sydd 1 metr i'r gogledd-orllewin o ffin gyffredin rhifau 6 ac 8 tua'r gogledd am bellter o tua 13 metr.

2. Teras Bryn, Brynsadler

- a. Yr ochr ogleddol, o bwynt sydd gyferbyn â ffin gyffredin rhifau 1 a 2 tua'r de-orllewin am bellter o tua 8.5 metr.
- b. Yr ochr dde-ddwyreiniol, o'i chyffordd â Heol Llanhari tua'r gogledd-ddwyrain am bellter o 5 metr.

3. Heol Llanhari, Brynsadler

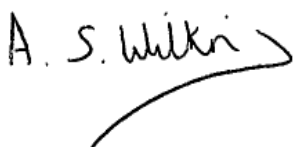
- a. Yr ochr ogledd-ddwyrain, o'i chyffordd â Theras Bryn tua'r de-ddwyrain am bellter o 5 metr.

ATODLEN 2 – Gwahardd Aros ar Unrhyw Adeg ac Eithrio Bysiau

1. Heol Llanhari, Brynsadler

- a. Yr ochr ogledd-ddwyrain, o bwynt 1 metr i'r gogledd-orllewin o ffin gyffredin rhifau 6 ac 8 tua'r de-ddwyrain am bellter o tua 19 metr.

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as specified in Schedule 1 and 2

SCHEDULE 1 – Prohibition of Waiting At Any Time

1. Danybryn, Brynsadler

- a. The western side, from its junction with Llanhari Road in a general northerly direction for a distance of approximately 41 metres.
- b. The eastern side, from a point opposite the common boundary of No's 46 and 47 in a general southerly direction for a distance of approximately 13.5 metres.
- c. The eastern side, from a point 1 metre north-west of the common boundary of No's 6 and 8 in a general northerly direction for a distance of approximately 13 metres.

2. Bryn Terrace, Brynsadler

- a. The northern side, from a point opposite the common boundary of No's 1 and 2 in a general south-westerly direction for a distance of approximately 8.5 metres.
- b. The south-eastern side, from its junction with Llanhari Road in a general north-easterly direction for a distance of 5 metres.

3. Llanhari Road, Brynsadler

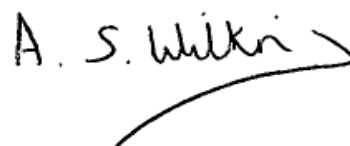
- a. The north-eastern side, from its junction with Bryn Terrace in a general south-easterly direction for a distance of 5 metres.

SCHEDULE 2 – Prohibition of Waiting Except for Buses

1. Llanhari Road, Brynsadler

- a. The north-eastern side, from a point 1 metre north-west of the common boundary of No's 6 and 8 in a general south-easterly direction for a distance of approximately 19 metres.
