P219 – Ffordd Llantrisant, Tonyrefail – Cynnig am Groesfan i Gerddwyr

Yn dilyn ymholiadau rheolaidd gan y gymuned i ddarparu croesfan ac i wella diogelwch cerddwyr ar hyd Ffordd Llantrisant, mae'r Awdurdod Lleol wedi datblygu cynigion i osod croesfan sebra rhwng tafarn The Red Cow ac Ysgol Gynradd Tref-y-rhyg.

P219 – Llantrisant Road, Tonyrefail – Proposed Pedestrian Crossing

Following longstanding calls from within the community to provide a footway and improve pedestrian safety along Llantrisant Road, Tonyrefail, the local authority has developed proposals to introduce a raised zebra crossing between the Red Cow public house and Tref-Y-Rhyg Primary School.

Further to the above, to improve visibility for all road users it is proposed to introduce double yellow lines and a junction realignment between The Avenue and Llantrisant Road itself. In addition, it will facilitate a localised narrowing of the carriageway whilst maintaining traffic flow.

The localised narrowing is necessary to allow the construction of a new 2-metre footway outside the Red Cow public house to create a safer environment for all highway users, especially pupils that attend Tref-Y-Rhyg Primary School.

The council is writing to residents to advise them of proposed changes and provide an opportunity for those directly affected by the proposals to submit their observations or make comment.
