STATE AID – DE MINIMIS

In order to minimise distortion of competition the European Commission sets limits on how much assistance can be given to organisations operating in a competitive market. The Enterprise Investment Fund is offered under the De Minimis Regulation (EC Regulation 1407/2013). This means that there is a ceiling of €200,000 for all De Minimis aid provided to an organisation over a three-year financial period.

Please let us know of any other De Minimis aid you have received during your current and previous two financial years, as we will need to check that our support, added to what you may have already received, will not exceed the €200,000 threshold.

We are only interested in public support which is De Minimis aid (aid received under other exemptions or public support which is not State Aid does not need to be declared). If you are in doubt about whether previous support is De Minimis aid, please contact the organisation that provided it.
