### CODE OF CONDUCT – Declaration of personal interests for inclusion in the public Register of Members' Interests

**ADVICE TO COUNCILLORS:**

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.
