# CODE OF CONDUCT – Declaration of personal interests for inclusion in the public Register of Members' Interests

**COUNCILLOR'S NAME: Emma Louise Dunning** 

#### **ADVICE TO COUNCILLORS:**

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

<u>Please remember</u> that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting – please look at the Council's Code of Conduct for the rules on this.

Please complete, sign and date <u>either</u> Box A <u>or</u> Box B below, and return the form to the Monitoring Officer.

### **BOX B - INTERESTS BEING DECLARED**
