CODE OF CONDUCT – Declaration of personal interests for inclusion in the public Register of Members' Interests

COUNCILLOR'S NAME: Karen Webb

ADVICE TO COUNCILLORS:

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

<u>Please remember</u> that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting – please look at the Council's Code of Conduct for the rules on this.

Please complete, sign and date <u>either</u> Box A <u>or</u> Box B below, and return the form to the Monitoring Officer.

BOX B - INTERESTS BEING DECLARED

- 1. Details of any employment or business carried on by you

This section relates to the Members residential address and has been deemed to be sensitive information as agreed by the Council's Monitoring Officer in accordance with Paragraph 16(1) of the Council's Member Code of Conduct.

- 8. Details of any body to which you have been elected, appointed or nominated by your authority

- (b) company, industrial and provident society, charity, or body directed to charitable purposes:
- (c) body whose principal purposes include the influence of public opinion or policy;
- (d) trade union or professional association; or
- (e) private club, society or association operating within your authority's area,

in which you have membership or hold a position of general control or management;
