CODE OF CONDUCT – Declaration of personal interests for inclusion in the public Register of Members' Interests

COUNCILLOR'S NAME: Paula Evans

ADVICE TO COUNCILLORS:

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

(There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this).

This form enables you to record those interests, or to show that you have no such interests to declare.

<u>Please remember</u> that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting – please look at the Council's Code of Conduct for the rules on this.

BOX B – INTERESTS BEING DECLARED

7. Details of any land where the landlord is your authority and the tenant is a firm in which you are a partner, a company of which you are a remunerated director, or a body of the description specified in (4) above

8. Details of any body to which you have been elected, appointed or nominated by your authority

9. Details of any -

(a) public authority or body exercising functions of a public nature;

(b) company, industrial and provident society, charity, or body directed to charitable purposes;

(c) body whose principal purposes include the influence of public opinion or policy;

(d) trade union or professional association; or

(e) private club, society or association operating within your authority's area,

in which you have membership or hold a position of general control or management;
