#### **Section 2: Constituency Activity**

I have engaged with residents and officers to secure improvements in 'residents only' parking arrangements in Aberdare, in general, and in Maesydre in particular. This has now reached an advanced stage with final implementation anticipated by approximately April 2016. This will be of lasting benefit to residents who are experiencing problems attributable to the fact that the number of permit holders exceeds parking spaces available.

I have continued to liaise with officers to secure highway improvements on the Aberdare bypass road, particularly at the Commercial street and Tinney street roundabouts.

An attempt to progress the ACIG scheme to renovate a local church for community areas continues but progress has been halted by the refusal of the church diocese to consider the building for community use. A change of opinion by the diocese at a future date could result in the resurrection of the scheme.

I have worked with residents of the 'Friends of Ty Mynydd' (effectively the Heol y Mynydd Residents Association) and officers to secure a bus stop on Monk Street to assist elderly and disabled residents to obtain access to their local GP surgery. This scheme is nearing completion with a successful outcome.

I continue to attend PACT meetings and meetings of the Maesydre neighbourhood watch, resulting in strong engagement on issues impacting on the local community.

#### **Section 3: Initiatives and Special Activities**

As Cabinet member for Health and Adult Social Services, I have had substantial involvement in progressing the requirements of the Social Services and Wellbeing Act, both as a member of the National Partnership Forum and also, as Chairman of the Cwm Taf Regional Board. The act will have a fundamental impact on social services when it goes 'live' in April 2016.

There has been significant improvement in terms of the identification of carers and the support and advice made available to them within Cwm Taf. I have had substantial involvement with this and was pleased to chair the first Carers Champions conference in Cwm Taf.

I am a member of the Aberdare Town Centre Forum and have successfully supported the regeneration of Aberdare Town Centre with improvements of the infrastructure including, roads, pavements renovations of prominent listed buildings.
