TITLE OF REPORT:

WITHDRAWAL OF LOCAL BUS SERVICES:

VEOLIA TRANSPORT CYMRU: REPLACEMENT CONTRACTS

PURPOSE OF ATTACHED REPORT: (containing exempt information as defined in paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely, information relating to the financial affairs of any particular person (including the authority holding that information). Transparency in the conduct of local authority business is desirable, however, personal financial information will be discussed and considered. Consequently, it is considered, the public interest in maintaining the exemption outweighs the public interest in disclosing the information).

To consider the outcome of the tendering of a number of contracted local bus services, in response to the decision by Veolia Transport Cymru to withdraw its operations from the Rhondda Cynon Taf area. In accordance with the Council's Scheme of Delegation, this report has been prepared to accompany the intended Officer decision of the Group Director Environmental Services, as described below.

DELEGATED DECISION (Date):

It is recommended that:

- (a) The outcome of the tendering of a number of contracted local bus services, in response to the decision by Veolia Transport Cymru to withdraw its operations from the Rhondda Cynon Taf area, is noted.
- (b) The Council awards new local bus service contracts, on the basis of the content of this report and the information set out in the table in Appendix A. It is intended that these contracts will be effective from no later than 24th June 2011 and run for approximately 9 months, with a planned expiry date of 31st March 2012.
- (c) In the event of a successful tenderer not being able to take-up the award of a
