#### 3. BACKGROUND

The Council received an application made by Treforest Residents Association care of Mr Michael Henry Weyman of 30 Meadow Street, Treforest, Pontypridd CF37 1SR under Section 15(2) of the Commons Act 2006 in respect of land known as The Bute, Treforest on 3<sup>rd</sup> March 2011. The land subject to the application is located to the south of Meadow Street and adjacent to the Pontypridd to Treforest Railway line.

Objections have been received from five parties offering conflicting evidence to the application.

The Council has an interest in the land forming the application by virtue of the ongoing development of the proposed Treforest Connect 2 cycle route / footpath between the University of Glamorgan Main Campus to its Glyntaf Campus as well as the Treforest to Tonteg Community Cycling Route.
