1. PURPOSE OF THE REPORT

3. BACKGROUND

- 3.1 As part of the introduction of Civil Parking Enforcement, a review of existing sites has identified a number of School Keep Clear markings that are not supported by a Traffic Regulation Order.
- 3.2 The Traffic Regulation Order will assist with enforcement, allow signs to be put up informing drivers that they should not stop on the markings creating a safer environment outside the schools.

South West side, from a point 2 metres south east of its junction with School Terrace south eastwards for a distance of 60 metres
