**1. PURPOSE OF THE REPORT**

**2. RECOMMENDATIONS**

**2.1 It is recommended that:**

- i. Public Notice is given under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 of the Council's making of a Consolidation Order of all of the Council's existing Traffic Regulation Orders as described in this report,

**3. BACKGROUND**

- 3.1 The council introduced Civil Parking Enforcement (CPE) in August 2012. At that time a consolidation order was made to take all of the existing Traffic Regulation Orders (TROs) which relate to parking offences on street made under the Road Traffic Regulation Act 1984 and to consolidate them into one Order which included the provisions of the original TROs.
- 3.2 This was necessary to include new and change some of the existing definitions and the terminology used in the TROs to ensure consistency and to reflect the changes in the enforcement regime. For example, enforcement is now undertaken by the Council's Civil Enforcement Officers (CEOs) and this definition needed to be included. A list of the revised definitions is given in Appendix A, and a list of the on street parking contravention which will be enforceable by the CEOs is given in Appendix B to this report.

- 3.3 Should there be a need to include new and change some of the existing definitions and terminology used in the TROs, as it applies to all TROs there would only be a need to make the change to the consolidation order.
- 3.4 Since the making of the consolidation order in August 2012, a further 80 TRO's, relating to parking offences on street including the Consolidation Order made in August 2012, have been made. There is a now a need to consolidate these into one order.
- 3.5 The Traffic Order Procedure Regulations allow Consolidation Orders to be made without carrying out formal consultation if there is no material change to the existing TROs. When there is no change of substance – such as, where the lengths of restrictions, or the times of the restrictions are amended – the process is purely administrative. In this case, as there is no change of substance, the Council need not advertise a proposal notice but only make the Consolidation Order and publish a Notice of Making.
- 3.6 The next stage in the process is to take all of the existing TROs which relate to parking offences on street (including the recent Variation Order) that have been made under the Road Traffic Regulation Act 1984 and to consolidate them into one Order which will include the provisions of the original TROs. The list of Orders to be consolidated is shown in the Schedule to this report but briefly comprises the following types:

- Prohibition of Waiting at any time
- Restriction of Waiting
- Prohibition of Waiting by a Specific Class of Vehicle ( i.e Commercial Vehicles)
- Prohibition of Stopping
- Prohibition of Waiting Except for a Specific Class of Vehicle (i.e. School Buses)
- Prohibition of Loading and Unloading
- Prohibition of Stopping in a Bus Stop Area
- Limitation of Waiting
- Loading Bays
- Doctors Parking Only
- Police Parking Only
- Taxi Ranks
- Disabled Persons Parking
- Residents Permit Parking

**STATEMENT OF REASONS**

On the 13th June 2012 the Welsh Ministers made the Civil Enforcement of Parking Contraventions (County Borough of Rhondda Cynon Taf) Designation Order 2012.

The Order designates the County Borough of Rhondda Cynon Taf as a civil enforcement area and a special area for the purpose of Part 6 of the Traffic Management Act 2004. The practical effect of the Order is to enable the Council to enforce parking contraventions within the County Borough.

This consolidation order will revoke all the traffic regulation orders and parts of traffic regulation orders listed in the Schedule to the Order and re-enacting the provisions of those orders relating to: -

- i. Prohibition and Restrictions of Waiting, Loading and Unloading
- ii. Prohibition of Stopping
- iii. Designated Bays for a specified class of vehicle
- iv. Residents Parking Places

as well as inserting the necessary references to Civil Parking Enforcement and Contraventions in accordance with the 2004 Act.
