APPLICATION FOR FUNDING FOR A CAPITAL DEVELOPMENT GRANT TO THE MUSEUMS, ARCHIVES AND LIBRARIES DIVISION

1. PURPOSE OF THE REPORT

- 1.1 The purpose of the report is to approve the submission of an application for capital funding of £300,000 to the Welsh Government's Museums, Archives and Libraries Division.

2. RECOMMENDATIONS

It is recommended:

- 2.1 That the application for funding is approved.

3 REASONS FOR RECOMMENDATIONS

- 3.1 The development of Taff Vale is a Council priority. It is a prime development site within the town and the new library/leisure hub is part of a wider regeneration programme designed to develop the local economy and improve the local environment.
- 3.2 The Council is committed to maximising the resources available from all sources for investment in the county.

4. BACKGROUND

- 4.1 The Council is committed to redeveloping the Taff Vale site as part of a much larger strategic programme whose aim is to regenerate Pontypridd and the surrounding area.
- 4.2 The Museums, Archives and Libraries Division of Welsh Government has a capital development fund for investing in libraries, archives and museums that is currently open for bids up to £300,000.



5. EQUALITY AND DIVERSITY IMPLICATIONS

- 5.1 There are no equality and diversity implications relevant to the current report.

6. CONSULTATION

- 6.1 In January 2016 views on the preferred future uses of the Taff Vale site were sought from local residents. Consideration has also been given to feedback provided by library users during customer surveys and informal feedback to librarians on the type of facilities and access they want from the service.

7. FINANCIAL IMPLICATION(S)

- 7.1 There are no financial implications as the application, if approved will merely apply for funding to support the Council to develop its plans.

8. LEGAL IMPLICATIONS OR LEGISLATION CONSIDERED

- 8.1 If the application for funding is successful the Council will be obliged to adhere to the clauses of the contract provided by Museums, Archives and Libraries Division and implement the funding as outlined in the application.

9. LINKS TO THE COUNCILS CORPORATE PLAN / OTHER CORPORATE PRIORITIES/ SIP.

- 9.1 The application for funding for development of a library on a co-located site is consistent with the Council's commitment in the Corporate Plan to redesign local services so that they are more integrated and efficient; investing in town centres so that they are vibrant and enticing with a strong offer which recognises that they are at the heart of our communities; and supporting the development of more involved and resilient communities.
- 9.2 The SIP highlights the fact that major improvement schemes in our larger town centres will act as a driver for regeneration of both the town centre and for neighbouring towns and villages.

10. CONCLUSION

- 10.1 Applying for funding that will, if successful, contribute to the financing of the development of the Taff Vale site is advisable as it will enable the Council to maximise its resources to deliver a flagship project in the county's main town.
