# REPORT TO ACCOMPANY A DECISION OF THE DIRECTOR OF EDUCATION AND LIFELONG LEARNING

Welsh Language Standards: Offer of Variation

#### 1. PURPOSE OF THE REPORT

1.1 The purpose of the report is to seek a decision on whether to agree to a variation to the Welsh Language Compliance Notice as proposed by the Welsh Language Commissioner.

#### 2. **RECOMMENDATIONS**

It is recommended:

that the variation to the Compliance Notice is approved.

## 3 REASONS FOR RECOMMENDATIONS

3.1 The Welsh Language Commissioner, after having considered the evidence submitted by the Council, has determined that the requirement for Rhondda Cynon Taf Council to comply with standard 41,52,58,64 and 69, or to comply with the standard in a particular way, was unreasonable or disproportionate. As a result the Commissioner has proposed a variation to the existing Compliance Notice. It is recommended that the Council agrees to this variation as it significantly reduces the burden on the Council by providing additional time to implement measures to meet these standards.

#### 4. BACKGROUND

4.1 On 30<sup>th</sup> September 2015 Rhondda Cynon Taf County Borough Council received its Final Compliance Notice from the Welsh Language Commissioner which indicated 171 standards which the Council was required to comply with and the imposition dates for compliance. 144 required compliance by 30<sup>th</sup> March 2016, 25 need to be complied with by 30<sup>th</sup> September 2016 and 2 by 30<sup>th</sup> March 2017.



- 4.2 On 30<sup>th</sup> March 2016 the Council submitted an appeal against the imposition of 14 standards, or imposition of these standards within the timescale indicated in the notice, as recommended by the Welsh Language Cabinet Steering Group and approved by Cabinet.
- A letter was sent to the Chief Executive on 6<sup>th</sup> June indicating that, having considered the appeal submission, the Welsh Language Commissioner's initial response was to determine against the Council's appeal in each instance. However, the Council was provided with an opportunity to provide further evidence to support its case within 10 working days.
- 4.4 Further evidence was submitted to the Welsh Language Commissioner within the specified time period and correspondence was received from the Welsh Language Commissioner on 12<sup>th</sup> August indicating her determination to vary the Compliance Notice in relation to 5 standards.
- 4.5 The variation proposed by the Welsh Language Commissioner is as follows:

Standard 41- the Council must comply with standard 41(a) in every circumstance except 'other papers that are available to the public, which relate to management board or cabinet meetings.'

The Council must comply with standard 41(b) in every circumstance except 'other papers for meeting that are open to the public.'

<u>Standard 52</u> – the Council must comply with standard 52 in relation to the body's corporate website by 31 March 2017.

The Council must comply with standard 52 in relation to all other websites by 31 March 2018.

Standard 58 – the Council must comply with standard 58 in relation to using social media on its main accounts by 31 March 2017.

The Council must comply with standard 58 when in relation to all other social media accounts by 31 March 2018.

Standard 64 – the council must comply with standard 64 in relation to the body's main reception service by 30 March 2016.

The Council must comply with standard 64 in relation to every other reception service by 31 March 2018.

Standard 69 – the Council must comply with standard 69 in every circumstance except for traffic notices by 31 March 2017.



The Council must comply with standard 69 in relation to traffic notices by 31 August 2017.

4.6 Although there is no change in the Welsh Language Commissioner's determination in relation to the remaining standards that were part of the appeal, this is a significant variation on the most challenging standards and the compromise is to be welcomed.

#### 5 **EQUALITY AND DIVERSITY IMPLICATIONS**

An Equalities Impact Assessment is not required.

#### 6 CONSULTATION

A consultation process has been undertaken with residents across Rhondda Cynon Taf to gather feedback on their priorities for Welsh Language services.

#### 7 FINANCIAL IMPLICATION(S)

There are no financial implications aligned to this report. However, there will be costs and resources as yet not fully ascertained in respect of implementation of the standards. Non-compliance with a standard could incur financial penalties of up to £5,000.

# 8 LEGAL IMPLICATIONS OR LEGISLATION CONSIDERED

Welsh Language (Wales) Measure 2011 and Welsh Language Statutory Standards 2015 regulate this area of work.
