REPORT OF DIRECTOR PUBLIC HEALTH, PROTECTION AND COMMUNITY SERVICES

1. PURPOSE OF THE REPORT

1.1 The purpose of this report is to approve the inclusion of Rhondda Cynon Taf CBC in the submission of an Expression of Interest (EOI) on behalf of the Central South Partnership in order to be considered as a partner in a future Regional Sports Partnership.

2. **RECOMMENDATIONS**

It is recommended:

- 2.1 Rhondda Cynon Taf CBC agree to participate as a full partner in the submission of an Expression of Interest (EOI) by the Central South Partnership to Sport Wales for consideration as a Regional Sport Partnership.
- 2.2 That the Head of Leisure, Parks and Countryside has delegated responsibility as the Lead Officer for RCT to supply the required information for inclusion in the EOI and to represent the Council in any future negotiations.

3. REASONS FOR RECOMMENDATIONS

- 3.1 Sport Wales is seeking to change the way they work with delivery partners including Local Authorities to deliver their Vision for Sport in Wales.
- 3.2 There will be a significant change from the current direct grant funding to individual Councils to deliver a Local Plan for sport to a regional based sport partnership.
- 3.3 For the purposes of submission of the EOI, RCT is part of a Central South area which includes Cardiff, Vale of Glamorgan, Bridgend, and Merthyr Tydfil Council areas.

4. BACKGROUND

4.1 There has been a long history of Sport Wales (previously Sports Council for Wales) directly grant funding local authorities to deliver sports development initiatives on a



countrywide basis. Prior to the introduction of the Local Authority Partnership Agreement (LAPA) in 2008, there was significant variance in funding between individual Councils. The LAPA sought to introduce a standard approach across the 22 Council areas and each Authority had to submit an annual plan containing various prescribed initiatives e.g. 5 x 60, Dragon Sport and more recently Free Swim.

- 4.2 In the first period of the LAPA the Council was receiving over £1 million per annum grant funding, split between Education and Leisure and employed over 20 staff to deliver the various initiatives.
- 4.3 However, more recently the level of funding from Sport Wales has been subject to an annual reduction. The grant settlement for 2019/20 now stands at £773K and the number of directly funded staff has reduced to 12 FTE.
- 4.4 Over the past 3 years Sport Wales has been reviewing their operating model and in particular how they work with sport national governing bodies (NGB's) and local authorities. Following a pilot with the 6 North Wales Authorities, Sport Wales has decided to move to a different model of operation by commissioning Regional Sport Partnerships.
- 4.5 In June 2019 Sport Wales held a number of consultation events across Wales to outline the proposed changes. This was followed by further events in October 2019 confirming the timetable for the implementation of Regional Sport Partnerships across Wales.
- 4.6 Sport Wales has set the following timeline for the procurement process:

- 4.7 In addition to the existing North Wales Regional Partnership which has been running since January 2018, 3 further EOI's are sought for the Gwent, West/Central and Central South Regions.
- 4.8 RCT is part of the Central South regional grouping together with Cardiff, Bridgend, Vale of Glamorgan and Merthyr Tydfil. Officers from the 5 Authorities, together with Cardiff Metropolitan University, who deliver Sport Cardiff on behalf of the Authority have been meeting regularly over the past few months with a view to formulating a regional response to Sport Wales.
- 4.9 The intention is to submit a collective EOI on behalf of the 6 partners to ensure that our collective stakeholding is represented in the future procurement of a Regional Sport Partnership.

5. EQUALITY AND DIVERSITY IMPLICATIONS

5.1 No equality and diversity implications have been identified at this stage of the process.

6. CONSULTATION/INVOLVEMENT

6.1 Sport Wales has consulted widely across all sectors in Wales with an interest/stakeholding in the delivery and development of Sport.

7. FINANCIAL IMPLICATION(S)

- 7.1 The Council currently receives in excess of £700K per annum directly from Sport Wales to fund the Council's 'Local Plan for Sport' including the Free Swim Initiative (FSI).
- 7.2 Subject to the outcome of the proposed way forward set out in Section 4, any financial implications for Rhondda Cynon Taf will be assessed and reported to Cabinet for consideration/approval.

8. LEGAL <u>IMPLICATIONS OR LEGISLATION CONSIDERED</u>

8.1 There are no legal implications at this stage although this may change as the procurement process develops.

9. <u>LINKS TO THE CORPORATE AND NATIONAL PRIORITIES AND THE WELL-BEING OF FUTURE GENERATIONS ACT</u>

- 9.1 The new regional approach aims to create an 'active nation' improving the health and well-being of Rhondda Cynon Taf residents and Wales as a whole.
- 9.2 The new regional approach works to achieve the Well-Being of Future Generations ("Wales) Act 2015 goals by using sport and physical activity as a catalyst to creating healthy and vibrant communities.



10. CONCLUSION

- 10.1 In order to ensure that Rhondda Cynon Taf CBC plays its full part in the delivery and development of sport in the County, it is essential that the Council confirms its interest in participating in Regional Sport Partnerships.
- 10.2 This will be best achieved by signing up to the Expression of Interest to be submitted by the Central South partnership by the submission deadline of 15th November 2019
