RECORD OF URGENT DECISION OF THE CABINET MEMBER

TO RESCIND THE DECISION OF CABINET TAKEN ON 24TH JANUARY 2024 RELATING TO CHARGING FOR THE ADDITIONAL CHILDCARE ELEMENT OF BREAKFAST CLUBS IN RHONDDA CYNON TAF

PENDERFYNIAD | DECISION

In January 2024 the Council determined to introduce a charge for the additional childcare element of provision alongside free breakfast clubs. A Copy of this decision can be accessed <u>here</u>.

The additional income generated was to be specifically allocated to schools as part of their 2024/25 budget.

In the ensuing period since the original decision of Cabinet Committee, discussions have taken place with school leaders and their trade union relating to respective responsibilities with regard to the existing provision, noting that the introduction of a charge would not have had any impact on such existing responsibility.

Alongside this, the Council has worked collectively to introduce a digital solution to the booking management for breakfast club places.

As a result of the protracted discussions, the implementation of the charge was deferred. It has therefore now been determined to no longer progress with the proposed introduction of a charge and to disseminate the information of this decision.

As no income was to be received as a consequence of the deferral to implementation, the school budgets were adjusted accordingly and schools have now approved their budgets for this financial year.

It is **Agreed** that:

- 1.1 That the previous <u>decision of Cabinet committee</u> taken on 24th January 2024 be rescinded; and
- 1.2To authorise the Director of Education & Inclusion to disseminate the details of this decision.
