### **CHILDCARE SUFFICIENCY ASSESSMENT UPDATE REPORT 2015**

### 1 PURPOSE OF THE REPORT

1.1 To provide Members with the draft Childcare Sufficiency Assessment Update Report 2015 (the 'CSA Update') for Rhondda Cynon Taf and the proposed CSA Action Plan Update 2015-16 for consideration.

### 2 **RECOMMENDATIONS**

It is recommended that Cabinet: -

- 2.1 Note the contents of this report;
- 2.2 Agree the CSA Update, as attached at Appendix 1 to this report;
- 2.3 Agree the implementation of the CSA Action Plan Update 2015-16; and
- 2.4 Request that a further report is presented to Cabinet before Christmas, providing an update on the changes to the childcare market, reflecting the implementation of the funding for nursery school provision.

### 3 LEGISLATIVE FRAMEWORK AND BACKGROUND

- 3.1 Local Authorities have a lead role in facilitating the childcare market, to ensure it meets the needs of working parents, especially those on low incomes, those with disabled children and those requiring childcare through the medium of Welsh.
- 3.2 Section 22 of the Childcare Act 2006 sets out the Council's duty to secure 'as far as is reasonably practicable' that the provision of childcare (whether or not by it) is sufficient to meet the requirements of parents in its area who require childcare in order to enable them to take up, or remain in, work, or to undertake education or training which could reasonably be expected to assist them to obtain work.
- 3.3 The Council is under a duty to have regard to Welsh Government guidance on how it discharges the duties set out above. The current applicable guidance is the 2008 guidance (WAGC 013/2008, Guidance to Local Authorities—

Childcare Act 2006). That guidance stipulates that the intention of the duties is to ensure parents are able to access childcare locally which meets their needs and enables them to make a choice about work.

- 3.4 The 2006 Act also requires the Council to prepare assessments of the sufficiency of the provision of childcare in its area and to review any such assessments prepared by it. The current regulations are The Childcare Act 2006 (Local Authority Assessment) (Wales) Regulations 2013.
- 3.5 As part of these duties a Childcare Sufficiency Assessment must be completed on a triennial basis, complemented by an annual update. The CSA Update, attached at Appendix 1 to this report, is an update of the third full Childcare Sufficiency Assessment produced by Rhondda Cynon Taf. The action plan is an update of the 2014-17 plan and details ongoing priorities for 2015-16.
- 3.6 Welsh Government provides an annual Out of School Childcare Grant to Local Authorities to support the work required for the CSA and the development and sustainability of local childcare. The grant is awarded on a year by year basis and for 2015-16 the grant awarded to Rhondda Cynon Taf amounts to £165,312.
- 3.7 The Council's proposals for 2015-16 have been submitted to Welsh Government and, at the time of writing, the Council are awaiting formal confirmation that the proposals are acceptable. Priorities for the use of this funding for 2015-16 include workforce training (including workshops to support CSSIW registration), commissioned support for children with additional learning and physical needs and grant support for childcare providers.

### 4 SUMMARY OF THE CSA UPDATE

- 4.1 The most significant development for childcare requirements in Rhondda Cynon Taf during 2014-15 is the Cabinet decision to approve plans to reduce the funding for 3 year old nursery education provision from full time (30 hours) to part time (15 hours) per week. It is anticipated that this will create some demand for childcare 'wrapped' around the part time nursery education offer.
- 4.2 This 'wraparound' childcare can be defined as childcare offered immediately before or after the part time nursery session in school, but during the hours of the normal school day. It is anticipated that this wraparound care will be offered on school site or via a pick up/drop off service by external providers.
- 4.3 Officers have used a number of indicators to identify schools where there is likely to be a demand for this service. This analysis included:
  - Identifying current childcare provision by ward
  - Identifying anticipated demand, utilising the Rochdale Formula, recommended as good practice within the Welsh Government CSA guidance. This formula utilises percentage of population under 14 years, percentage of lone working parents and WIMD score

- Mapping the above supply and demand data to identify the likely high demand/low supply wards (table 2 in the CSA Update)
- 4.4 This mapping, together with the following indicators provided an overall score for each school:
  - From the nursery public consultation, wards where more than 35% of respondents indicated that childcare may be an issue
  - Schools with more than 35 pre-nursery and nursery children currently on roll

Using the above indicators the maximum score that schools could receive was four. In total ten schools scored three or four (table 8 of the CSA Update), where demand is <u>likely</u> to be highest. These schools are the priority for further investigation into wraparound childcare requirements.

- 4.5 The governing bodies of all affected schools have now confirmed their nursery provision from September 2015. Sixty six schools intend to continue to offer full time nursery education using school budgets. Thirty three schools intend to offer part time nursery education in line with revised funding. Of these 33, five have plans in place to offer wraparound childcare on school site from September 2015. Officers are supporting these schools if required and are also continuing to work with those other schools where there is an identified likely demand.
- 4.6 Additionally, in order for officers to determine <u>actual</u> demand from parents, and to identify any unexpected pockets of demand, a questionnaire has been sent to all affected parents in the 33 schools stated above. The results of this questionnaire will be used to plan development work over the coming year.
- 4.7 The CSA Update reflects the demand for childcare prior to the implementation of the school nursery funding changes. We were unable to accurately predict the future childcare demands placed upon the market in preparing the CSA Update. Therefore, it is proposed that, a further report is prepared and presented to Cabinet in the Autumn, setting out the developments in the childcare market arising from the changes to the nursery school funding and any further action required by the Council to meet changes in the demand and supply of provision.
- 4.8 Encouraging unregistered childcare provision to register with Care and Social Services Inspectorate Wales (CSSIW) continues to be a priority for the Council. To support this, during 2014 we commissioned a series of workshops to support providers to go through the registration process. We plan to commission another series of workshops during 2015-16 to continue this support. Priority will be given to unregistered childcare providers in areas of identified need.
- 4.9 Rising costs, increasing vacancies and parent/carer preference to use family or friends for their childcare needs, means that the sustainability of childcare providers continues to be a concern. A grant scheme is in place to support the sustainability of childcare providers and the development of new provision in areas of identified need. During 2014-15, we received 36 grant applications, of which 29 were fully or partly funded. This scheme will

- continue during 2015-16, with particular emphasis on supporting development of wraparound childcare in areas of identified need.
- 4.10 The delivery of nursery education in non-maintained Registered Education Providers (REP's) continues to be an important element of the delivery of nursery education in Rhondda Cynon Taf. In order to align these REP's with maintained nursery education, the number of hours of provision will increase in September 2015 from the current 10 hours per week to 15 hours per week. There are currently 20 REP's throughout Rhondda Cynon Taf, offering approximately 400 additional nursery education places per annum from the term following the child's 3<sup>rd</sup> birthday. Closer links are currently being made with the admissions team in Education and Lifelong Learning (E&LL) so that pre-nursery and REP provision can become more integrated in the admissions process. There will also be greater emphasis on registering REP's in areas where there is an identified need.
- 4.11 The full CSA 2014-17 identified a continuing demand for one to one support for children with additional learning and physical needs to access holiday childcare and play provision. During the last 18 months this scheme has been restructured and support is now administered via the Holiday Fun Time scheme. During 2014-15, 670 children received 3476 sessions of provision in 61 childcare and play settings. Subject to continued funding, this support will continue to be available to children and families during 2015-16.
- 4.12 The Family Information Service (FIS) continues to be a valuable source of information to families, childcare providers and professionals. The FIS website has been redeveloped during 2014-15. The recruitment of FIS Outreach Officers has also allowed for more interaction with childcare providers and community groups, ensuring that the accuracy of data is more accurate and up to date. During 2015-16 FIS Outreach Officers will continue to meet with childcare providers, community groups and professionals such as Jobcentre Plus advisors.
- 4.13 There are currently 26 Flying Start (FS) areas in Rhondda Cynon Taf, offering childcare to over 700 eligible children aged 2-3 years. Wherever possible third sector organisations are encouraged to tender for FS childcare contracts and the majority of this entitlement in Rhondda Cynon Taf is delivered in this manner. FS has therefore made a significant contribution to the sustainability of childcare providers although some have struggled to meet the exacting standards required for FS. In some areas, especially in deprived areas, no tenders were submitted and so existing local authority nurseries are being maximised to meet the FS needs on a full cost recovery basis. Four new areas are due to become FS during 2015-16 and officers are currently commissioning providers to deliver this provision.
- 4.14 The CSA Action Plan Update 2015-16 identifies 16 key priorities that will continue to drive our partnership work over the next year to support the development, and sustainability, of childcare provision in areas of identified need and for children with specific requirements:

- 1. CSA published every three years, with an annual update report, in accordance with Section 26 of the Childcare Act 2006;
- 2. Increase parental awareness of financial support for childcare costs, particularly for those wishing to enter employment and/or training;
- 3. Increase the number of CSSIW registered out of school clubs by 10% per year;
- 4. Develop childcare provision in areas of identified need;
- 5. Support the development of wraparound care for 3 year olds nursery pupils in areas of identified need;
- 6. Administer a grant scheme to support sustainability of childcare settings and the development of new provision in areas of identified need;
- 7. Develop closer links with the admission team to improve the co-ordination and delivery of nursery education for 3 year olds in Registered Education Provision (REP);
- 8. Support the development of Welsh medium childcare in areas of identified need;
- 9. Identify opportunities to improve access to childcare and early years provision for children with additional learning and physical needs;
- 10. Support 75% of eligible children to access Flying Start childcare provision;
- 11. Identify and support the training and workforce development needs of childcare providers;
- 12. Improve the quality of childcare settings beyond the National Minimum Standards:
- 13. Pre-school childcare providers are engaged in and delivering the Healthy Pre-Schools initiative;
- 14. Develop closer links with employers in RCT and Business Support agencies to better support the needs of working parents;
- 15. Investigate the childcare needs of children and young people aged 8-14 years;
- 16. Improve collaboration with the Planning department regarding childcare related planning applications.
- 4.15 Following a review of service requirements, responsibility for the CSA and the Welsh Government Out of School Childcare Grant has transferred from Early Years and Family Support Services (EYFSS) to E&LL on 1st April 2015. The

Early Years Advisory Teachers who support REP's are now also the responsibility of E&LL. This will ensure improved collaboration between childcare and education providers in Rhondda Cynon Taf and also that the admissions process for REP's is more easily aligned with school admissions procedures.

### 5 CONCLUSION

- 5.1 Rhondda Cynon Taf is well placed with its existing childcare provision to meet the current needs of most working parents and this will be kept under review during 2015-16 to ensure that changes in demand arising from the nursery school funding reduction are met as fully as possible.
- 5.2 It is considered that implementation of the CSA Action Plan Update 2015-16, within available resources, will address the other challenges identified in point 4.14.

### 1. Introduction

All Local Authorities in Wales have a responsibility (Section 22, Childcare Act 2006) to secure, as far as is reasonably practicable, sufficient childcare to meet the requirements of parents/carers who require childcare in order to work, undertake training/education or to prepare for work. Local Authorities have the lead role in facilitating the childcare market to ensure it meets the needs of parents/carers, particularly those on low incomes, those with children with disabilities or those who wish their children to attend Welsh medium provision.

Section 26 of the Childcare Act 2006 requires Local Authorities to prepare Childcare Sufficiency Assessments (CSA's) every three years in order to have a clear understanding of the childcare provision in their area, the needs of parents/carers and to develop an action plan to address any gaps identified. In Rhondda Cynon Taf (RCT), the full CSA Report 2014-17 carried on the work of previous CSA's. This report provides an update on those findings.

### **Priority 1:**

CSA published every three years, with an annual update report, in accordance with Section 26 of the Childcare Act 2006

Changes to the provision of nursery education for three year olds in RCT are likely to have an impact on childcare demand over the coming year (see *2.1.3*). It is therefore important to recognise that this CSA update report has been prepared in accordance with Welsh Government requirements but will need to be updated on a regular basis over the course of 2015 and 2016 to reflect the changing demand and supply of childcare provision in RCT.

## 2. Executive Summary

Following a review of service requirements, responsibility for the CSA has transferred from Early Years and Family Support Services (EYFSS) to Education & Lifelong Learning (E&LL) with effect from 1<sup>st</sup> April 2015.

This 2015 CSA update report provides an overview of the findings of the full CSA 2014-17 report, analyse the current childcare supply and report on significant developments in the last year. It also reports progress on actions within the three year action plan, as well as identifying new priorities for 2015-16.

Unless stated otherwise all data used within this report is correct as at 31st December 2014. A detailed ward analysis has been undertaken and is available as an appendix to this report (see *Appendix 4*).

### **Update since 2014 Full Audit** 2.1

A substantial amount of work has been undertaken over the last twelve months to map the current childcare provision in RCT, both registered and unregistered. Officers from EYFSS have worked alongside Family Information Service (FIS) Outreach Officers and colleagues from other departments to ensure that data on existing provision is up to date and that this mapping exercise is as thorough as possible.

On 12<sup>th</sup> February 2015, the Council's Cabinet, after a period of consultation, determined to change the funding arrangements for nursery education provision for 3 year olds from full time (30 hours) to part-time (15 hours) per week, with effect from 1st September 2015. This could have a significant impact on the demand and supply of childcare provision. However at the time of writing it has not yet been possible to identify neither where demand will be on a ward by ward basis nor how this demand will be met.

A comprehensive consultation process was undertaken to help inform the report presented to Cabinet members. A public consultation was undertaken from 21st October 2014 to 30th January 2015, which included nine public consultation events. 727 responses (679 online/paper questionnaires, 40 emails and 8 letters) were received from members of the public during the consultation process. Officers also contacted a selection of childcare providers and school headteachers. The aim of this exercise was to establish their views on the possible impact that the changes may have on their settings. 54 childcare providers in RCT were contacted as well as 18 infant and/or primary schools. From this data, officers have established where potential gaps may exist and where demand for additional childcare may be most needed. This is discussed in more detail in **2.1.3** below.

The section below provides an overview of developments in RCT over the past year.

### 2.1.1 Unregistered settings

There are still out of school and sessional care providers in RCT, who are not registered with Care and Social Services Inspectorate Wales (CSSIW) and operate for less than two hours per day (15/30 out of school providers and 17/58 sessional care providers). All registered providers are required to comply with National Minimum Standards (NMS). This ensures that parents/carers can be confident that all staff are suitably qualified and experienced and that the setting is of a high quality. Registration also enables parents/carers to apply for childcare vouchers via their employer or financial support through the tax credit system (if eligible).

To enable eligible families to access this financial support, thereby helping to ensure that affordability is not a barrier for parents/carers, the Council continues to encourage unregistered settings to become registered with CSSIW. To support this, during 2014, we commissioned a series of workshops to support providers to go through the registration process. At the time of writing, these workshops had supported four settings to complete their registration packs to be submitted to CSSIW by the end of March 2015, whilst a further three plan to submit their registration packs within the next few months. This will result in approximately an additional 170 registered places throughout RCT. Using the Welsh Government Out of School Hours Childcare Grant, we plan to commission another series of workshops during 2015-16 to continue to support the registration of childcare settings.

### **Priority 3:**

Increase the number of CSSIW registered out of school childcare clubs

### 2.1.2 Sustainability of settings

Anecdotal evidence over the last year suggests that rising costs as well as falling numbers

of children are continuing to have a detrimental impact on childcare providers. Provider feedback in the full CSA 2014-17 report suggested that parents/carers continued to use family or friends to meet their childcare needs and this looks to still be the case. Providers reported that there is also a continuing trend towards families only requiring part time paid childcare provision.

EYFSS operates a grant scheme to support the sustainability of childcare providers and the development of new provision in areas of identified need. In 2014-15, we received 36 grant applications from early years and childcare providers. Of these, 29 were fully or partly successful in achieving financial support. Subject to continued funds, this grant scheme will continue to offer financial support to childcare settings in 2015-16. Priority will be given to grant applications from settings in areas identified in this report as priority areas, or to those who can demonstrate a clear demand for new provision or expansion of current provision.

### **Priority 6:**

Administer a grant scheme to support sustainability of childcare settings and the development of new provision in areas of identified need

### 2.1.3 Proposed changes to nursery education

It is anticipated that the proposed changes to nursery education will create a demand for childcare 'wrapped' around the part time nursery education offer, (herein referred to as wraparound care).

For the purposes of this report, wraparound care is defined as childcare offered immediately before or after the part time nursery session in school, but during the hours of the normal school day. Wraparound care can be offered on school site or via a pick up/drop off service by external providers. This wraparound care may link into current breakfast, after school or sessional childcare provision.

The public consultation on the proposed changes to nursery education identified several geographical areas where a lack of childcare provision may be an issue for parents/carers when the changes are implemented. The number and percentage of responses can be seen in *Table 1* below:

Across the whole borough, the Council envisages that most increases in demand will be accommodated via current childcare provision. Where this is not possible, officers will work with schools and childcare providers to agree the most suitable solutions. Feedback suggests that several childcare providers have planned for the changes to nursery education and have already amended their CSSIW registration and/or opening hours to cater for the possible increase in demand for wraparound care.

Of the 54 childcare providers consulted during the public consultation period, 72.2% said they were planning to offer, or would probably offer, wraparound provision. Of those consulted, providers indicated they could, or possibly could, offer care in all of the wards identified in *Table 1* except eight. Of these eight, Tonyrefail West and Penygraig have been identified as requiring further exploration (see *Tables 7 & 8*) and will be a priority for childcare investigation for 2015-16. Despite this feedback from childcare providers, it is recognised that it may still be necessary to support the development of new provision in some of these areas. Officers from EYFSS and Education & Lifelong Learning (E&LL) are working closely with schools and childcare providers to support the development of wraparound care in areas of identified need. This will be ongoing and one of the main priorities for 2015-16. Key to this successful implementation will be supporting workforce development to ensure that all staff have the appropriate qualifications.

### Priority 5:

Support the development of wraparound care for 3 year olds nursery pupils in areas of identified need

### 2.1.4 Registered Education Providers

The majority of nursery aged children (approximately 94%) are able to access nursery education in their local infant or primary school. Where this is not possible, limited places are available within private or voluntary, non-maintained registered education settings.

There are currently 20 Registered Education Providers (REP's) within the Local Authority (see *Appendix 2*). These REP's follow the Foundation Phase curriculum and are inspected by Estyn in the same way as nursery education in the maintained sector. Early Years Advisory Teachers (EYAT) support these settings to ensure that the principles of the

Foundation Phase are implemented to meet Estyn standards. They also offer advice and support on maintaining high standards and training needs.

REP's currently offer 10 hours per week of free nursery education. As part of the changes to nursery education, the Council will fund an increase of 5 hours per week to 15 hours from September 2015. Closer links are currently being made with the Admissions team within E&LL so that pre-nursery and REP provision can become more integrated in the admissions process. These closer links will also ensure a smoother transition for children into full time school education at age 4 and ensure that the Admissions team is aware of all nursery aged children, whether attending a maintained or non-maintained nursery setting. There will also be greater emphasis on registering REP's in areas where there is an identified need (subject to available funding). This work will be ongoing throughout 2015-16.

### **Priority 7:**

Develop closer links with Admissions team to improve the co-ordination and delivery of nursery education for 3 year olds in non-maintained settings (Registered Education Providers)

### 2.1.5 One to One Support

Previous CSA's have identified continuing growth in demand for one to one support to enable children with additional learning and physical needs to access out of school childcare and play settings. Without this support, many children are unable to access this provision due to the high costs associated with the specialist support they require. The Council has traditionally offered financial support for children to attend holiday play and childcare settings. During the course of the last 18 months, this scheme has been restructured and support is now administered via the Holiday Fun Time scheme.

The Holiday Fun Time scheme offers support to children requiring one to one support or specialist equipment, and also to those children deemed vulnerable by Social Services (to offer, for example, respite care). The scheme has grown considerably during 2014. In the period from April to December 2014, 687 children have been referred onto the scheme and 670 have received 3476 sessions of provision in 61 childcare and play settings.

The majority of vulnerable children are placed in settings close to their homes. This is to facilitate their inclusion within their own communities. However, for children with significant mobility support needs there are currently three settings across RCT with the appropriate equipment and staff to accommodate their needs. This can result in these children having to travel some distance from their home addresses. This will continue to be monitored during 2015-16 with additional settings being identified wherever possible.

Subject to continued funding, the number of referrals to this scheme will undoubtedly grow again during 2015-16. Currently this scheme only offers this support during the school holiday periods. The number of requests for term time support to access out of school childcare is also increasing. Investigation of a system to support school aged children in term time will be one of the priorities for officers during the coming year.

### **Priority 9:**

Identify opportunities to improve access to childcare and early years provision for children with additional learning and physical needs

### 2.1.6 Family Information Service

The Family Information Service (FIS) has gone through a substantial period of change over the last 18 months. The FIS website has been redeveloped which has led to an increase in online enquiries of 175% between 2013/14 and 2014-15.

FIS now employs three Outreach Workers (one each for Rhondda, Cynon and Taf areas). They have proven to be beneficial in raising the profile of the service and creating links with childcare providers, other Council departments and voluntary/community organisations.

The ward analyses in *Appendix 4* contain details of FIS enquiries for each area. This data refers only to the period 1<sup>st</sup> September – 31<sup>st</sup> December 2014. The redeveloped FIS website was not fully operational before this period and so the accuracy of data collated before this time cannot be relied upon. Although the time period used to capture data is quite small, FIS are confident that it is indicative of the number, and type, of enquiries throughout a 12 month period.

During the period September – December 2014, FIS received 91 enquiries regarding childminders, 69 for English medium playgroups, 45 for day nurseries, 26 for Welsh

medium playgroups (Cylch Meithrins) and 24 for after school clubs. The highest number of enquiries came from Rhydyfelin Central/llan and Tonypandy wards with 19 enquiries each. The types of enquiries are detailed in the ward analyses (*Appendix 4*). Rhydyfelin has a wide range of childcare provision available, mostly within the Integrated Children's Centre that is based there. FIS do not currently keep data on whether enquiries are successful (i.e. that the enquirer is able to find the type of childcare that they are looking for). However for Rhydyfelin it is reasonable to presume that most of the enquiries were met due to the number and type of childcare places available in that ward. Tonypandy, on the other hand, has limited childcare provision available. The high level of enquiries may be because parents/carers are aware of this and are looking outside of their immediate area for childcare provision.

Eight wards had no enquiries for childcare or play settings. Four of these areas have an identified *low demand* for childcare and therefore it is reasonable to presume that the lack of enquiries was due to a lack of demand. The other four areas had an identified *high demand*, with only one having an associated *high supply*. The three wards with an associated *low supply* have been identified as areas where further investigation is needed. It is possible that the lack of enquiries in these areas is due to lack of knowledge of the FIS service.

Obtaining up to date information from providers continues to be a challenge, but has improved considerably as the FIS Outreach Workers now visit providers to complete the database forms. Follow up telephone calls also ensure that the information on the FIS database is accurate.

### 2.1.7 Flying Start

Flying Start is the Welsh Government's targeted early years programme aimed at families with children below four years of age in some of the most deprived areas in Wales. It offers eligible parents/carers funded quality childcare for 2-3 year olds, parenting support, an enhanced health visitor service and help for early language development. The funded quality childcare consists of 2.5 hours a day for all eligible 2-3 year olds, 5 days a week for 42 weeks.

The majority of Flying Start settings are currently engaged with the Welsh Government's Healthy and Sustainable Pre-Schools Scheme (HSPSS). This scheme supports the basic

principles and learning framework of Flying Start by contributing to the social, emotional and physical development of children. This will continue to be an ongoing priority for Flying Start settings during 2015-16.

In RCT, there are currently 26 Flying Start areas, offering childcare to over 700 children aged 2-3 years. This equates to approximately 25% of all children in this age range in RCT. During 2015-16, four additional Lower Super Output Areas<sup>2</sup> (LSOA's) will join the programme:

- Cwmbach 2
- Treorchy 3
- Aberdare East 4
- Ystrad 3

These will make an additional 336 0-3 year olds eligible for Flying Start and will require an additional 72 commissioned childcare places. Officers are currently commissioning providers to deliver Flying Start provision for the four new areas.

The Programme has had an impact on available provision for 2-3 year old children and must be considered within the three yearly CSA and within this annual update. In some areas, new sessional care has been established, whilst in other areas existing childcare settings have been commissioned to offer a set number of existing childcare places to deliver Flying Start provision.

It is the policy of RCT that, wherever possible, Flying Start settings will be 'mixed economy' (the settings can accept fee paying children alongside Flying Start funded children). This can aid the sustainability of settings by utilising surplus places. It also ensures that there is still provision available for fee paying parents/carers so that the Flying Start provision does not have a negative impact on childcare availability locally.

### Priorities 10 & 13:

Support eligible children to access Flying Start childcare provision Pre-school childcare providers are engaged in and delivering the Healthy and Sustainable Pre-Schools Scheme (HSPSS)

### 2.1.8 Assisted Places

The authority commissions Clybiau Plant Cymru Kids Club (CPCKC) to administer an Assisted Places grant scheme to allow low income families access to out of school childcare places, both in term time and during school holidays. This scheme is funded via the Welsh Government Out of School Childcare Grant. It has proved to be a valuable financial support for parents/carers. During 2014-15 funding was available to support all eligible applications. In total 30 children were funded and were able to access 1689 out of school and holiday childcare sessions. The scheme is also a valuable source of sustainability support for childcare settings, as it allows them to fill vacancies. The Council will look to continue this scheme in the coming year.

### 2.1.9 Free Breakfast Clubs

Although not defined as childcare, the Welsh Government Free Breakfast Initiative offers a vital support to parents/carers at the start of the school day. In RCT, there are currently 109 free breakfast clubs in infant, primary and special schools (43 in Rhondda, 29 in Cynon and 37 in Taf).

There remain a few fee paying breakfast clubs in RCT, the majority of which are within external childcare settings. These provide a valuable service to parents/carers, as the opening times tend to be longer than those for the free breakfast clubs. Fee paying clubs are typically open from 7.30am to the start of school, whereas free breakfast clubs do not open until 8am-8.15am. According to FIS data, the average cost for this type of provision is currently £4.47 per hour.

### 2.1.10 School Holiday Childcare

The full CSA 2014-17 report states that 75% of parents/carers are satisfied with term time childcare arrangements, whilst this falls to 54% of parents/carers for school holiday childcare arrangements.<sup>3</sup>

It is recognised that high quality, reasonably priced school holiday childcare remains a challenge. This is especially so for the older age range (8-14 years) who do not want to be 'looked after' in traditional childcare settings.

A priority for the coming year will be to look at cost effective holiday care options, especially for older children. Possible solutions may include developing 'Playcare' provision, which can reduce the daily fee quite considerably. However, this remains dependant on funding for open access playscheme provision and on the individual providers' ability to employ suitably qualified staff to run the childcare element of the day.

Officers are also working with CPCKC to support childcare providers to develop out of school and holiday clubs specifically for the older age range. One club is currently in development for children and young people aged from 9-14 years. Officers will monitor the success of this club with a view to rolling the model out across RCT.

### **Priority 15:**

Investigate the childcare needs of children and young people aged 8-14 years

### 2.1.11 Housing / Employment Developments

The ward analyses in *Appendix 4* include details of all planning applications that have achieved full planning approval during 2014 (those for 10 units or more per application). As with previous CSA reports, the Taf area of RCT has received the highest number of housing development applications, with approximately 500 houses approved for the Beddau/Church Village/Tonteg area. Developments in the Hawthorn and Rhydyfelin wards have also achieved planning permission with 72 units approved. There was only one application in the Cynon area (Aberdare East ward). This development consists of predominantly one bedroom flats and is therefore unlikely to have an impact on the childcare needs of that area. There were three applications approved in the Rhondda area. Again these were predominantly for one bedroom apartments and are unlikely to impact on childcare needs. This will be monitored to understand the accuracy of this hypothesis.

This update report does not consider housing developments that received full planning permission prior to 2014 and are currently in the building phase. Previous CSA reports will be consulted to monitor the childcare demands of these developments. Using E&LL analysis of where there will be increases in the number of required school places (due to

housing developments) officers will monitor where there may be increased demand for childcare provision. It must also be remembered that developers have a period of five years from the date of permission in order to implement the consent, and so those applications approved in 2014 have until 2019 to be built and so therefore may not impact on childcare demand immediately.

### **Priority 16:**

Improve collaboration with the Planning department regarding childcare related planning applications

The employment market has remained fairly static in RCT over the last year. There have been no major redundancy situations, other than approximately 25 redundancies at a company on the Treforest Industrial Estate. The most significant job creation during 2014 was the development of four restaurants on the site of an old Comet store in Talbot Green ward. Approximately 70 jobs were created across the four units. The majority of these are part time jobs. There is no data to suggest that this had led to an increase in demand for childcare in this area.

The RCTCBC Business Support Grant records the number of jobs created in businesses that have received grant support. During 2014, a total of 40 jobs were created in 19 wards as a result of this business support. Aberdare East and Talbot Green wards saw the highest number, with 6 jobs each created. The South East Wales Local Investment Fund created 72 jobs in 23 wards. Abercynon and Pontyclun wards saw the highest number with 8 jobs each created. Again, there is no data to suggest that this job creation has led to an increase in childcare demand that cannot be met by current provision.

Closer links are currently being developed with Jobcentre Plus and Regeneration & Planning officials. This will ensure that the Council is aware of major job creation opportunities or losses at an early stage so that appropriate support and information can be offered to the childcare sector.

### **Priority 14:**

Develop closer links with employers in RCT and Business Support agencies in order to better support the needs of working parents/carers

### 2.2 Gap Analysis

The following section explores in more detail where there may be particular gaps in childcare supply and demand and provides an update on the full CSA 2014-17 report.

### 2.2.1 Geographical Analysis

The full CSA 2014-17 report found that vacancy rates amongst many providers were increasing, especially in the Taf area of RCT.<sup>5</sup> So that officers can fully understand the current childcare situation, it is necessary to map, as far as is possible, what childcare provision is available in what areas. The mapping exercise undertaken during the last year has allowed officers to identify wards where there is little or no childcare provision. However, this alone does not tell the Council about the demand for childcare in that area and it does not consider where there may be gaps between childcare supply and demand. In order to calculate this, officers have followed the Welsh Government guidance in the CSA toolkit in order to identify the wards in which more exploratory work may be needed.<sup>6</sup>

Using data from the Office for National Statistics, the Council can determine that there are 41,426 children and young people aged from 0-14 years in RCT, from a total population of 236,114. This equates to 18%, which is slightly higher than the Wales average of 17%. Alongside this data, officers have identified how many childcare places are available per ward (see *Appendix 1*). For the purposes of this analysis, registered open access play provision and Welsh Government Free Breakfast Clubs have been excluded.

This tells the Council that there are currently 4086 childcare places (both registered and unregistered) available overall in RCT or 9.86 places per 100 children. Based on the population figures, 3110 childcare places are required overall, suggesting there is currently an oversupply of 976 places. However, it must be remembered that this oversupply is based on the childcare market before the changes to the nursery funding for 3 year olds from September 2015 have an impact. It is also important to note this is a general assessment of the childcare market in RCT and does not take into account the types of childcare available, the age groups catered for nor the number of vacancies within each setting. Also, it does not take account of capacity within childcare settings. The total number of places available does not always correlate with the actual number of places that a setting can offer (due to staffing restraints, sustainability etc).

However, it does give a starting point for assessing childcare supply in each geographical area. The data in *Appendix 1* can be used as a very basic analysis to group each ward using the categories on the following page (see *Table 2*). This suggests there are 12 wards with a *perceived high demand* / *low supply* of childcare. Further investigation will take place during 2015-16 to determine if there is, in fact, a demand for additional childcare in these areas, and if so what types are required.

**Priority 4:** 

Develop childcare provision in areas of identified need

### 2.2.2 Income Analysis

Overall, RCT is the third most deprived Local Authority in Wales, as measured by the Welsh Index of Multiple Deprivation (WIMD) 2014. 17.5% of LSOA's in RCT are in the 10% most deprived in Wales. These levels of deprivation correlate with families' ability to pay childcare costs. Of the 12 wards identified in **Table 2**, 5 include LSOA's in the top 10% most deprived in Wales. This may be one indicator why there is limited childcare provision in these areas and must be taken into account when investigating childcare demand in more detail.

Consultation with parents/carers in the full CSA 2014-17 report found that 48% of respondents used partners/family/friends to care for their children, with 32% stating the reason was that childcare was too expensive. Similarly, employer feedback stated that 67% felt that childcare should be more affordable for employees. The majority of those consulted offered childcare benefits to their employees. 50% offered an on-site nursery, followed by 33% who offered childcare vouchers with a similar number offering employees information about working tax credits.

From the recent public consultation on nursery education proposals, many respondents stated that they may have to reduce their working hours or cease work altogether as the increase in childcare costs will be too great. This was particularly evident amongst lone parents/carers with 31 out of 50 respondents stating that they would need to stop/reduce/delay work or training as a result of the proposals.9 It is not yet possible to determine if affordability of wraparound childcare will have a detrimental impact on those parents/carers who will be affected by the proposals. However, officers will closely monitor and support the development of provision, and work with schools and childcare providers to ensure that it is competitively priced and of high quality.

Ensuring that childcare provision is accessible and affordable for parents/carers continues to be a key priority for the Council. Further information is available in Section 2.1, but some of the support available includes:

• The Assisted Places grant scheme for low income families (in particular for parents/carers to continue/return to work or training)

- The Holiday Fun Time scheme that funds referred children with additional learning or physical needs to access holiday childcare and play provision
- The Welsh Governments' Flying Start programme and Free Breakfast initiative support families to access free childcare for eligible children
- The FIS website has a range of information for parents/carers regarding available financial support and advice.<sup>10</sup> FIS Outreach Officers also attend Jobcentre Plus lone parent sessions, parent & toddler groups and parenting groups to offer information on a variety of financial support for families
- Unregistered childcare providers are supported (via workshops and 1:1 sessions) to register with CSSIW so that eligible parents/carers can access financial support
- EYFSS offer a childcare provider grant scheme to support the development, expansion and sustainability of childcare provision, so that parents/carers can access high quality, affordable childcare
- In line with the changes to nursery education, the number of hours of funded education in Registered Education Providers will increase from 10 hours per week to 15 hours per week from September 2015

### **Priority 2:**

Increase parental awareness of financial support for childcare costs, particularly for those wishing to enter employment and/or training

According to current FIS data, the average cost for childcare **per hour** in RCT is:

Using the Family and Childcare Trust 2015 Childcare Costs Survey as a comparison, average costs in RCT are 2.76% higher than the Wales average for day nurseries and 6.91% higher for childminders. However, this analysis is based on a fairly small number of childcare providers who have submitted this information to FIS. During 2015-16, the FIS Outreach Officers will consolidate and increase their data so that it provides a more thorough overview of childcare costs. Additionally, although the Council has no control over the fees set by childcare providers, officers will continue to offer advice and support to try and ensure that fees remain competitive and good value for money.

### 2.2.3 Specific Needs Analysis

There is a range of support available to children in RCT with additional learning or physical needs. External agencies and council departments work collaboratively to provide children and young people with good quality play and early years' experiences. The range of support currently available includes:

### Disabled Children's Team

This service offers personalised support to children who meet the DCT disability criteria and have a high or medium level of need.

### Education Psychology Service

Educational Psychologists assess the needs of children where there is a concern about their development, learning or behaviour. This team work with parents/carers and schools to develop a plan of support. There is now a dedicated Flying Start Educational Psychologist, based with EYFSS, to support children identified through the Flying Start programme.

### Flying Start

### Law yn Llaw

This is a Local Authority funded scheme, providing 1:1 support for pre-school children with additional needs to enable them to access community based pre-school playgroups through the medium of welsh and English.

### Portage Service

This service offers support for parents/carers and families of children aged 4 and under who have developmental delay in two or more areas.

### • Sure Steps

Sure Steps is an intensive pre-school service for children aged 2-3 years who have been diagnosed with autism or are suspected of being on the acute end of the autistic spectrum.

### Talk and Play

This programme includes Language and Play, Number and Play and Talkabout. It supports parents/carers to communicate and play with their children. Talk and Play is a creative and practical community based service to support and advice on speech, language and literacy development in order to reduce longer term speech, language and communication difficulties.

The public consultation on nursery education proposals indicates that there is some concern about the impact of the proposals on children with additional needs. 2.8% of respondents reported that their child(ren) have a disability that requires special support. Comments from this group of parents/carers highlighted the negative impact the changes will have on children's learning and their development of social skills, independence and confidence.<sup>12</sup> As with all childcare provision, consideration must be taken of the needs of children with learning or physical impairments and wraparound childcare provision will be no exception to this.

### Numbers of vulnerable children

As at 31<sup>st</sup> December 2014, there were 485 child protection cases within RCT. This was a similar figure to that reported in the full CSA 2014-17 report (477).

The highest number of cases was for the 2 years and under age range (152), whilst the 15-17 years age range had the lowest number of cases (30). The ward with the highest total number of child protection cases was Cymmer (25), whilst the wards with the lowest number were Graig, Taffs Well and Talbot Green (1 case each).

Under Sections 17 and 18 of the Children Act 1989, the authority complies with its duty to purchase appropriate childcare places for children in need when necessary. This is currently delivered via a variety of settings, including Flying Start (of which Cymmer is a Flying Start area), council run full day nurseries as well as through a network of specially trained childminders. The changes to nursery education are likely to have an impact on the childcare needs of vulnerable children in the 3-4 year old age range. Any increase in demand will be accommodated via the current arrangements. This will be closely monitored to ensure that current supply is adequate.

The figure for Looked After Children (LAC) as at 31<sup>st</sup> December 2014 was 657. Again this is a similar figure to that reported in 2014 (640).

The highest number of LAC was in the 11-14 years age range (147), whilst the lowest number were children aged 3-4 years (70). There is no evidence to suggest that the childcare needs of LAC are not accommodated via the current supply of childcare across the authority. This will continue to be monitored.

### Numbers of disabled children

As at 31<sup>st</sup> December 2014, there were 622 children within RCT whose additional needs met the criteria for support from the Disabled Children's Team. This is an increase of 10 on the figure reported in the full CSA 2014-17 report (612).<sup>13</sup> Children who do not meet these criteria can be signposted to TAF (Team Around the Family) or Third Sector organisations that accept self referrals, such as the Viva project.<sup>14</sup>

For the purposes of the CSA, consideration must be given to the needs of disabled children in the 15-17 age range. Social isolation and a lack of out of school opportunities that develop independence skills are recognised as a need for this age group. Although

not strictly childcare, closer links with the Youth Engagement and Participation Service (YEPS) would be beneficial in ensuring that the needs of this age group are not overlooked.

### Ethnic background

2011 Census data suggests that RCT has become more ethnically diverse in the ten years since the 2001 Census. The population of RCT that stated they were from ethnic minority backgrounds rose from 1% in 2001 to 2.6% in 2011. This is still well below the Wales average of 4.4%.<sup>15</sup> 1.7% reported that their main language was one other than English or Welsh.<sup>16</sup> There is no evidence to suggest that these ethnic groups are unable or unwilling to access current childcare provision because of their ethnicity or language. This will be kept under review.

### 2.2.4 Time Analysis

The full CSA 2014-17 report found that childcare was not available at the times needed for 6% of parents/carers consulted. This was typically between 7.30am-9am and 3.30pm-6pm as well as weekends and during school holidays.<sup>17</sup> 42% of employers consulted felt that childcare provision could be improved by being available at different times.

Childminders continue to offer the most flexible childcare for parents/carers who work atypical hours. FIS data shows that five (3%) childminders currently offer care before 7.00am on weekdays, whilst 10 (7%) offer care after 6.00pm. Six (4%) childminders state they can offer care on Saturdays with three (2%) stating they can offer care on Sundays. This figure is comparable with the full CSA 2014-17 report that stated seven (5.6%) childminders offered weekend care.<sup>18</sup>

Despite the challenges of staffing costs for day nurseries to offer care at weekends, before 7.00am or after 6.00pm, there seems to be a willingness to explore this option, with at least one day nursery offering Saturday childcare. Four (12%) day nurseries have stated that they open at 7.00am but only one (3%) states a closing time after 6.00pm.

The public consultation on nursery education proposals identified concern from parents/carers over a perceived lack of childcare 'wrapped' around the nursery education offer. This was particularly evident in the Taf area of RCT where 19 of the 34 postcode areas were located. 19 However, consultation with childcare providers suggests that many are planning to offer wraparound childcare to meet the anticipated demand. 72.2% of childcare providers who responded to the public consultation exercise are planning to offer, or will probably offer, wraparound provision. The location of these providers in relation to areas identified in the public consultation is detailed in **Table 1**.

### 2.2.5 Age Analysis

The mid-2013 population estimates used in this report suggest a slight decrease in the population of 0-14 year olds compared with the 2011 Census data (see *Table 5*).<sup>20</sup> The 10-14 year age group showed the biggest decrease of 6.2%, whilst there was a rise in the number of 5-9 year olds, up 4.7%. This suggests that further investigation is needed to ensure that there is sufficient childcare provision for this age range. This trend looks set to continue with 2017 population projections showing the number of 5-9 year olds increasing by a further 10%. The number of 10-14 year olds is also set to return to 2011 levels with a 6.5% rise, thereby cancelling out the decrease shown in 2013. The number of 0-4 year olds shows a steady increase with a rise from 14,449 in 2011 to 15,018 in 2017, an overall increase of 3.9%.<sup>21</sup> This population data can be used to inform officers of the childcare needs for each age group.

Using data in the ward analyses (see *Appendix 4*), Rhigos has the lowest number of children in all categories from 0-14 years, suggesting the need for childcare in this particular ward is limited, although the childcare analysis suggests (*Appendix 1*) that Rhigos is a *high demand / low supply* area. This anomaly will need further investigation to determine the exact needs in this ward.

Pontyclun has the highest number of children in all categories from 0-10 years whilst Aberdare West/Llwydcoed has the highest number of young people aged from 11-14 years. Again, the childcare analysis is at odds with this data, as both wards are defined as high demand / high supply, suggesting there is sufficient childcare to meet demand. As mentioned in 2.2.1, this childcare analysis does not take account of specific types of childcare and so further investigation is needed to establish this. Parental feedback in the full CSA 2014-17 report indicated that the availability of childcare provision for children over the age of 8 years drops significantly. Further investigation work will be undertaken during 2015-16 to establish if there is a need for out of school and holiday care for the 8-14 year age range. The population estimates suggest that if there is a demand, it is likely to increase over the coming two years.

The public consultation on nursery education proposals also indicates that there may be an increased need for care for 3 year olds when not accessing their nursery education place. Trying to address identified gaps for this particular need will be a priority during 2015-16.

Based on the mapping exercise that has been undertaken, officers have been able to identify where there are gaps in childcare provision for certain age ranges. With regards to sessional care, there appear to be registered and/or unregistered settings in each ward in the Rhondda area, suggesting that pre-school provision for 2-3 year olds is well catered for. Those wards within the Cynon and Taf areas with no sessional care provision will be investigated during 2015-16 to determine if there is a demand in these areas.

Childminders are fairly well represented across the whole of the authority and can offer care across the age ranges.

There remains limited out of school care within RCT, with the majority of wards having no specific out of school provision. Based on the population projections above, this must be a

continued priority for development. However, it must be remembered that childminders and day nurseries also offer out of school care but are not included in this particular analysis. This will need to be taken into account when investigating out of school childcare needs.

As you would expect, there are many wards within RCT without any form of day nursery provision. However, this is not to say that there is a demand for more to be established. Day nurseries are often registered to care for large numbers of children and so can cater for children from a wide geographical area, outside of their immediate location.

### 2.2.6 Type Analysis

FIS data, along with the mapping exercise conducted by officers, shows that there is a wide range of childcare provision within RCT (see *Table 6*). Whilst most childcare provision is registered with CSSIW, there still continues to be a high number (14.8%) of unregistered childcare places.

### Welsh language profile

As at January 2015, there are 24 Welsh medium sessional care providers in RCT (21 registered with CSSIW, 3 unregistered), offering approximately 550 places for 2-3 year olds. Eleven of these are also Registered Education Providers and six are commissioned to deliver Flying Start provision.

There have been no changes in the number of Welsh medium sessional providers in the last year. However, FIS data suggests one provider has changed their CSSIW registration from sessional to full day care, in order to offer out of school and holiday care. This may also include wraparound care when the proposed changes to nursery education provision come into force.

There are currently ten out of school clubs offering care to children attending Welsh medium primary schools. Three are registered with CSSIW, whilst seven are currently unregistered. Combined, they offer approximately 180 places for 3-11 year olds in term time, with 30 places available during school holiday periods. One new club has opened in the last year, increasing the number of available places by approximately 16.

FIS data found that five (4.6%) childminders offer 'Bilingual' or 'Welsh and English' medium care, whilst 68 (63%) state that they offer 'Predominantly English with some use of Welsh'. Four (12.1%) day nurseries stated they offer 'Bilingual', 'Welsh and English' or 'Welsh medium only'. 25 (75.8%) stated they offer 'Predominantly English with some use of Welsh'. Overall, there appears to be limited childcare provision that can offer a fully Welsh medium service. However, parent feedback in the full CSA 2014-17 report suggested that only 6.7% of parents/carers preferred Welsh medium childcare provision. This may indicate that parents/carers are happy for their children to receive care in settings that are 'Predominantly English with some use of Welsh'. This will continue to be monitored during the coming year.

During 2015-16, special consideration will be given to the provision of Welsh medium wraparound care. 28.5% of respondents to the public consultation on the nursery education proposals stated that their child(ren) attend a Welsh medium nursery, education or childcare setting, and there was concern that the proposals will have a detrimental effect on the Welsh language development of children. Less exposure to Welsh, especially for children from English speaking families was highlighted as one of the main concerns in this consultation.<sup>22</sup>

2011 Census data shows that Pontypridd Town ward has the highest percentage of residents who can speak, read and write in Welsh (15.7%) with Church Village ward a very close second (15.6%). At the time of writing, Pontypridd Town does not have any Welsh

medium childcare provision, although there is a Welsh medium out of school club and a Cylch Meithrin in neighbouring wards. Church Village ward is well catered for in regards to Welsh medium provision. The Gartholwg campus offers childcare, play and education opportunities from birth through to 18 years, as well as a Lifelong Learning Centre on site.

Trealaw ward has the lowest percentage of residents who can speak, read and write Welsh (6%) with Penrhiwceiber second lowest (6.4%).<sup>23</sup> There is no specific Welsh medium provision in Trealaw, although there are three Cylch Meithrin and one Clwb Carco in neighbouring wards. In Penrhiwceiber, the Flying Start setting offers Welsh medium sessions for those parents/carers who have stated this preference.

### **Priority 8:**

Support the development of Welsh medium childcare in areas of identified need

# **2.3 Priorities for 2015-16**

The following areas will be the main focus for development work during 2015-16. These actions are included in the CSA Action Plan Update 2015-16 (see *page 36*), along with existing priorities from 2014-15.

### 2.3.1 Financial support and advice for families and childcare providers

A range of support and advice will continue to be offered to childcare providers and families during 2015-16. The Family Information Service will continue to signpost families to possible financial support for childcare costs. This will be via their website and email/telephone enquiries, but also through attendance at a variety of childcare settings and community events. FIS Outreach Officers will also continue to attend lone parent advice sessions to give advice on available childcare provision and possible financial support for childcare fees.

The EYFSS childcare provider grant scheme will offer financial support to new childcare developments and sustainability/expansion of existing settings.

The Assisted Places grant is also available to support low income families access out of school and holiday childcare places.

#### 2.3.2 CSSIW registration

A continuing priority for 2015-16 will be to encourage and support unregistered out of school and sessional care providers to register with CSSIW. Using the Welsh Government Out of School Hours Childcare Grant, we plan to commission another series of workshops to support the registration of out of school childcare settings.

#### 2.3.3 Childcare development

Using the data contained within this report, a detailed analysis of each ward has been undertaken to establish which areas will be the priority for 2015-16. Further investigation will be undertaken to identify if there is an actual need for additional childcare, and if so, what types and for what age range. As part of the analysis, each ward has been awarded points according to the following criteria:

• Wards with at least 35% of responses in the public consultation on changes to nursery education stating lack of childcare would be an issue

- Wards identified as high demand / low supply
- Wards with 6 or more FIS enquiries
- Wards with no sessional care (as at Dec 2014)
- Wards currently with no out of school care (as at Dec 2014)
- Wards currently with no full day care (as at Dec 2014)
- Wards currently with no childminders (as at Dec 2014)

One point was awarded for each criterion. Using this data, one ward scored 6, two scored 5 and eight scored 4:

#### Wraparound care

The same process was undertaken to identify the schools where there may be a demand for wraparound care, and if developed, has the best chance of being financially viable. Each school has been awarded points according to the following criteria:

- If the school is in a ward with at least 35% of responses in the public consultation on changes to nursery education stating lack of childcare would be an issue
- If the school is in a ward identified as high demand / low supply
- Schools with more than 35 pre-nursery and nursery children currently on roll (as at Jan 2015 intake)

One point was awarded for each criterion, whilst two points were awarded to those schools with 55 or more pre-nursery and nursery children on roll. Using this data, one school scored 4, whilst nine scored 3:

It is important to note that this is a very basic analysis and does not take into account the individual needs of schools that have scored less than 3 in this exercise. Support will, of course, be offered to schools who request it or who can demonstrate a clear parental demand. This analysis though, helps officers to identify the schools that will be the first to have their wraparound options investigated during 2015-16.

It must also be remembered that individual school governing bodies may choose to continue to offer full time (30 hours per week) nursery education even though they will be funded for part time (15 hours per week) provision.

The schools listed in *Table 8* will only be offered support on potential wraparound options if their governing bodies do make the decision to offer part time nursery education in line with their funding. If they decide to offer full time education for the academic year from September 2015, they will not need the immediate support of officers in this matter.

The wards of Cilfynydd, Hirwaun, Penygraig, Tonteg and Tonyrefail West feature in both *Table 7* and *Table 8* and so therefore the schools in these wards will be investigated before the schools in the other four wards.

# Holiday care

As detailed in **2.2.5**, out of school care, particularly during school holiday periods, will be investigated further during 2015-16. Parental feedback suggests that there is a lack of

holiday care for 8-14 year olds. This has been identified as a need in previous CSA reports. However, although it is accepted that this older age group do not want to access traditional 'childcare' with younger children, it can be difficult to sustain childcare provision specifically to cater for this need, as attendance numbers may not be sufficient to cover costs. Officers will work with childcare providers and other Council departments to explore possible, cost effective solutions. Aberdare West/Llwydcoed and Pontyclun will initially be examined as the population data shows these wards have the highest number of resident 8-14 year olds.

### 2.3.4 1:1 support

One to one support for children with additional physical and learning needs is well developed within RCT for school holiday periods. Term time support is available to support pre-school children to attend sessional care childcare via the Law yn Llaw scheme. Work will be undertaken during 2015-16 to develop the support available for school aged children to access out of school clubs. The Welsh Government Out of School Hours Childcare Grant will be used to support this.

# 2.3.5 Welsh medium provision/ethnic minority groups

Ensuring parents/carers have access to childcare provision delivered through the medium of Welsh will continue to be a priority for 2015-16.

Currently, there is no evidence to suggest that families from minority groups (such as BME, those whose first language is not English or for gypsy/traveler families) are not able to access current childcare provision. However, this will continue to be monitored during 2015-16 and action taken if the situation should change.

## 2.3.6 Training

A key priority for 2015-16 will be to signpost practitioners to appropriate training and qualifications to support the continuing professional development of childcare and early year's professionals. The Welsh Government Out of School Hours Childcare Grant will be used to commission a Level 3 Children's Care, Development and Learning (CCLD) course, as well as a Level 3 Transition to Playwork course for early years professionals. This will meet identified training needs for the development of wraparound childcare provision and out of school care.

### **Priority 11:**

Identify and support the training and workforce development needs of childcare providers

### 2.3.7 Quality of Settings

EYFSS will continue to support childcare and early year's providers to improve the quality of their service. This will include support and advice from officers, signposting settings to relevant external agencies, promoting the RCT Quality Assurance Scheme for Early Years, Childcare and Play Provision and the Healthy Schools initiative.

## **Priority 12:**

Improve the quality of childcare settings beyond the National Minimum Standards



There are therefore 529 children and young people aged 0-14 years in the Cwm Clydach ward or 19% of the total population.

One English medium sessional care provider is currently delivering Flying Start provision for eligible 2-3 year olds. 24 children are currently registered to receive this provision.

### Changes in childcare supply

During the last year, there have been no known changes to the childcare supply in this ward.

This ward has one LSOA in the top 10% most deprived in Wales. Cwm Clydach 1 is ranked 25<sup>th</sup> most deprived LSOA in RCT and 180<sup>th</sup> in Wales.

# Three year old nursery provision

There is one English medium primary school in the Cwm Clydach ward with 28 children currently enrolled in the nursery class (pre nursery and nursery, as at December 2014).

There are no Registered Education Providers in this ward.

In the public consultation on the proposed changes to nursery education, 2 responses were received from this ward, although none stated that lack of childcare would be issue.

# Other developments

There have been no full planning applications for housing developments over 10 units approved during 2014.

#### Summary

Cwm Clydach is one of the wards identified in *Table 7* and the analysis in *Appendix 1* suggests that there is a *high demand* and *low supply* of childcare in this ward. It will therefore require further investigation of childcare needs, although the analysis suggests that just an additional 2 places are required. This does not tell us what type or for what age range these are needed.

#### 4.2 Cymmer

#### **Population**

Cymmer has a population of 5444 (ONS mid-2013 population estimates) of which:

- 220 are aged 2 years and under
- 135 are 3-4 years
- 193 are 5-7 years
- 150 are 8-10 years
- 215 are 11-14 years

There are therefore 913 children and young people aged 0-14 years in the Cymmer ward or 17% of the total population.

#### Childcare supply

The current childcare provision in this ward is as follows:

This ward has one LSOA in the top 10% most deprived in Wales. Cymmer 3 is ranked 12<sup>th</sup> most deprived LSOA in RCT and 86<sup>th</sup> in Wales, whilst Cymmer 4 is ranked 9<sup>th</sup> in RCT and 71<sup>st</sup> in Wales.

### Three year old nursery provision

There is one English medium primary school and two English medium infant schools in the Cymmer ward with a total of 56 children currently enrolled in the nursery classes (pre nursery and nursery, as at December 2014). One of the infant schools closed in December 2014 with children transferring to other schools in the area.

There are no Registered Education Providers in this ward.

In the public consultation on the proposed changes to nursery education, 8 responses were received from this ward, with 2 stating that lack of childcare would be issue.

#### Other developments

There have been no full planning applications for housing developments over 10 units approved during 2014.

#### Summary

The analysis in *Appendix 1* shows that there is *low demand* and *low supply* of childcare in this ward. This suggests that it is unlikely for the market to develop additional childcare and intervention may be required to stimulate demand. The analysis indicates that an additional 34 places are required, although this does not tell us what type or for what age range these are needed. Further investigation may be required.



# Three year old nursery provision

There is one welsh medium Registered Education Provider in this ward, with 10 children currently funded to receive 3 year old nursery education.

In the public consultation on the proposed changes to nursery education, 6 responses were received from this ward, although none stated that lack of childcare would be issue.

#### Other developments

In 2014, planning was approved for 19 social housing dwellings on land adjacent to Dyffryn Road, Rhydyfelin. This development is within half a mile of Heol y Celyn Primary School. The development is for a mixture of two bedroom houses/apartments as well as 1 x 3 bedroom house and 1 x 4 bedroom house. Achieving planning permission does not mean that building work will start imminently so determining the impact on childcare needs is difficult to calculate. When building works are completed, this development may have some impact on childcare needs in the area.

# Summary

The analysis in *Appendix 1* shows that there is *low demand* and *high supply* of childcare in this ward, suggesting that there is sufficient childcare provision and possibly an oversupply, leading to possible sustainability issues for the settings. This analysis suggests that there is an oversupply of 39 childcare places. This will be kept under review.

This analysis indicates that there is an oversupply of 44 childcare places. However, the Full Day Care provider is located on the Coleg y Cymoedd Further Education campus so it is reasonable to presume that the children attending this setting are from a wide geographical area. Therefore this may distort the analysis for this ward.
