1. To authorise Age Connects Morgannwg to undertake the necessary consultation and the development of a Big Lottery Bid to develop a intergenerational community hub at St Mair's Day Centre;

2. That a subsequent report is presented to Cabinet in September 2017 once the consultation has been completed and Age Connects Morgannwg's

funding application has been completed.

3. To consider at the Cabinet meeting in September 2017 whether a 99 year lease for St Mair's Day Centre is granted to Age Connects Morgannwg, subject to a Big Lottery Funding approval.
