SUBJECT: COUNCIL CORPORATE PLAN - INVESTMENT PRIORITIES

1. DECISION MADE:

Agreed –

1. To propose the release of earmarked reserves, undertake prudential borrowing and resultant Investment Priorities as detailed at Appendix A to Council at its meeting on 24th October 2018, subject to the inclusion of an additional £100k from the Infrastructure reserve to support flood prevention works.
2. To receive a further update in early 2019 on Earmarked Reserve availability as part of the normal budget strategy work being undertaken in preparation for the 2019/20 financial year.
