SUBJECT: Extra Care Development Programme

1. DECISION MADE:

Following the consideration of the report of the Group Director, Community & Children's Services containing exempt information as defined in Paragraph 14 of Part 4 of Schedule 12A of the Local Government Act, 1972 (as amended), namely information relating to the financial affairs of any particular person (including the authority holding that information), it was

AGREED:

- 1. To note the progress made on the development of the Aberaman and Pontypridd extra care schemes.
- 2. To approve the funding package as outlined in Section 5 of the exempt report to develop the Aberaman extra care scheme.
- 3. To approve the funding package as outlined in Section 6 of the exempt report below, to develop the Pontypridd extra care scheme.
- 4. To include the Pontypridd extra care scheme within the 3-year capital programme (modernisation programme (Adults)).
- 5. To receive further update reports on progress in delivering the Council's Extra Care Housing Strategy and development programme and on individual scheme costs and funding requirements for consideration and approval.

2. REASON FOR THE DECISION BEING MADE:

The Council's Extra Care Housing Strategy and development programme previously approved by Cabinet agreed that progress and individual scheme costs and funding would be further reported for consideration and approval.

Extra care will support the delivery of the Council's corporate priority "promoting independence and positive lives for everyone" by helping local people with care and support needs to stay living independently at home.
