#### 2. REASON FOR THE DECISION BEING MADE:

Further to the approval of the Council's Three-Year Capital Programme 2021/22 - 2023/24 on 10th March 2021 at Council, this report sets out the detailed capital programme for Highways, Transportation and Strategic Projects.

The investment programme supports the Council's Corporate Plan Priority 'Places – Where people are proud to live, work and play'.

The programme is wide ranging. It deals with the maintenance and provision of transport assets created in order to meet travel demand. The programme supports enhanced connectivity to link homes with employment opportunities, education, and health facilities, and to act as a catalyst for development and regeneration. In conjunction with grant applications, a range of sustainable and active travel opportunities are promoted.

The programme also seeks to reduce flood risk and insulate communities from the damaging impacts of climate change in light of more frequent extreme weather events.

The programme supports the Well-Being goals fostering prosperity and resilience with inclusive and sustainable transport options supporting more cohesive and vibrant communities.
