Issue: Business Planning Update

Summary

The first year of implementation of the improved system of business planning was completed at the end of March 2018. Impact review meetings were held with each drive team at the end of the summer, autumn and spring terms and the progress made recorded. Previous reports have provided a summary of progress regarding implementation. A report provided Members at the June meeting with a summary of completion and impact. However performance data was not available at that time. This reports provides that data and compares with previous performance and targets set.

The business plan 18/19 runs from 1st April 2018 to 31st March 2019. It was approved by Joint Committee on 15th March 2018. The detailed operational plans that underpin this plan were presented to Members in June. This report provides a summary of progress made in the first term of implementation.

- 5. Performance that is greater than the previous year is highlighted in yellow.
- 6. Targets that were exceeded by actual performance are highlighted in orange.
- 7. The tables show that:
 - Foundation Phase performance is lower than in previous years. Whilst this was anticipated by many schools because of the change in the outcome indicators, the absence of targets makes it difficult to know if the extent of the dip is as expected.
 - Performance exceeded that of the previous academic year in 18 of the 29 performance indicators
 - The performance gap between those pupils entitled to free school meals and those not entitled remains unacceptable.
 - Target setting was generally accurate:
 - i. For 22 out of 25 performance measures the actual was within 5% of target set
 - ii. For 18 out of 25 performance indicators the actual was within 3% of the target set
- 8. The Business Plan 2018-2019 was approved by Joint Committee on 15th March 2018.
- 9. It has four priorities that relate directly to The National Mission.
 - Priority One: To Develop A High Quality Education Profession
 - Priority Two: To Develop Inspirational Leaders And To Facilitate Their Working Collaboratively To Raise Standards
 - Priority Three: To Develop Strong And Inclusive Schools Committed To Excellence, Equity And Wellbeing
 - To Develop Robust Assessment, Evaluation And Accountability Arrangements Supporting A Self Improving System

12. The plan is ambitious and challenging. It outlines the region's role in delivering the extensive education reform agenda, whilst ensuring improved outcomes for pupils. Progress made in the first term of implementation is satisfactory or better in 235 out of 255 actions. (92%)

The 20 actions where only limited progress has been made have been identified on the monitoring sheets and barriers to progress addressed.
