#### 1. PURPOSE OF REPORT

1.1 As requested by Children and Young People Scrutiny Committee on December 19<sup>th</sup> 2018, this report provides information on a recently completed perception survey undertaken in the new all through schools created as part of the Band A 21<sup>st</sup> Century Schools and Education Programme a year into operation.

#### 2. <u>RECOMMENDATIONS</u>

It is recommended that Committee Members:

2.1 Scrutinise and provide comment on the perception survey outcomes as informed by the evaluation and monitoring exercise recently carried out for the new all through schools created as a part of the Band A 21<sup>st</sup> Century Schools and Education Programme.

#### 3. REASONS FOR RECOMMENDATIONS

- 3.1 To provide the opportunity for Scrutiny Committee to comment upon the progress achieved through the delivery of the Band A 21<sup>st</sup> Century Schools and Education Programme, specifically the perceived impact of a range of stakeholders on the benefits of this investment on a range of measures including:
  - Educational Outcomes;
  - Educational Provision;
  - Leadership and Management.

3.2 Scrutiny will recall that as part of the statutory consultation process for the Rhondda Valley and Tonyrefail school reorganisation proposals, a consultation document was shared with all relevant stakeholders. The proposed benefits of the proposals, as listed above, were outlined in the consultation document and these have been used as the basis for the evaluation.

#### 4. BACKGROUND TO THE REPORT

- 4.1 The £173m investment through the Band A 21st Century Schools and Education Programme has delivered significantly improved learning environments and opportunities for learners. In addition to this, the Band A programme has removed over 3,600 surplus places; reduced the carbon footprint of RCT's schools; increased participation in sporting activities on the new 3G pitches; increased leisure facility usage as reflected in Junior More card memberships; delivered innovative STEM projects, and created apprenticeships and work based programmes during the construction phase of the new school facilities.
- 4.2 On the 19<sup>th</sup> December 2018 RCT's Director of Communications & Interim Head of Democratic Services provided a report to the Children and Young People Scrutiny Committee to invite them to engage in the formal consultation process for the Band B 21<sup>st</sup> Century Schools Modernisation Proposals for the Cynon Valley and Greater Pontypridd areas.
- 4.3 Scrutiny will be aware that at the meeting of Children and Young People Scrutiny Committee in December 2018 it was requested that a report evaluating the progress of the new schools created as a part of the Band A 21<sup>st</sup> Century Schools and Education Programme be brought back to Scrutiny for comment.
- 4.4 Scrutiny members will be aware that it was agreed that this report would be presented to Scrutiny following a full year of operation of the new schools created by the Rhondda Valley and Tonyrefail school reorganisation, allowing them an opportunity to settle in. The management of change process that the schools have undergone has been intensive and the organisational changes implemented extensive. In light of this, it was felt that time was needed to create a new and shared school vision and culture; a highly effective workforce; and robust policies and procedures consistently implemented so that learners had the best chance of achieving success.
- 4.5 The Committee Chair accepted that while these schools had been provided with first class facilities, it was too soon to receive outcome data. Subsequently, the Committee resolved to receive a progress report in 12 months' time to see how the new Band A schools were progressing. The Committee also resolved that learners and staff of these schools should be invited to contribute to the evaluation process.
- 4.6 As a result, the Council has undertaken an initial perception survey of learners, staff, governors, parents and carers of the new all through schools

created by the Rhondda Valley and Tonyrefail school reorganisation, delivered under Band A of the 21<sup>st</sup> Century Schools and Education Programme. The all through schools consulted were:

- Tonyrefail Community School;
- Porth Community School;
- Ysgol Nantgwyn.
- 4.7 The investment in these schools amounted to circa £80M and involved an ambitious proposal to reorganise education in the Rhondda Valley and Tonyrefail by creating three new 'all through' schools.
- 4.8 The surveys were written in partnership with officers from RCT's Education and Inclusion Services and the headteachers of the schools were actively involved in the consultation. This ensured that the questionnaires were coconstructed in partnership with schools.
- 4.9 It was unilaterally agreed that an online survey would be more manageable for the schools to implement, as electronic consultation would ensure the timely collation of responses and the effective analysis of data. This process was managed by RCT's Corporate Policy team. Copies of the surveys used for the consultation are attached in Appendix A.

### 5. <u>PERCEPTION SURVEY</u>

- 5.1 In order to protect the right of respondents to their privacy and in accordance with the consultation privacy policy, individual responses cannot be reported on. Data has been anonymised, and only overarching trends and findings from the consultation are reported on.
- 5.2 The surveys were sent out to schools on Wednesday 20th November 2019 and were available for 4 weeks. A total of 1,022 surveys were returned by respondents across the 3 all through schools involved in this consultation. The response figures for the different groups involved vary considerably, with surveys returned by 638 learners, 137 staff, 17 governors and 230 parents/carers.
- 5.3 Surveys provided a focus on educational outcomes (standards, wellbeing, transition); educational provision (learning experiences, learning environment); and leadership and management (training, leadership, partnership). The structure of the surveys is based on Welsh Government evaluation guidance for completed 21<sup>st</sup> Century Schools projects. Specific post occupancy surveys, which will largely focus on the new environments created using 21<sup>st</sup> Century Schools funding, will be conducted as a separate exercise and will comprise focus groups of learners and staff. These results will be reported to Welsh Government in compliance with the funding terms and conditions.
- 5.4 These areas of educational outcomes, educational provision, and leadership and management are deemed by Welsh Government and Estyn to be appropriate benchmarks of school performance. The survey results are

presented below in the form of the average positive response rates across the schools surveyed, with no individual school data reported.

- 5.5 The Education Amendments relating to Teacher Assessment Information Wales Regulation 2018 highlights that teacher assessments can be used for information purposes but not for school accountability purposes. In view of this teacher assessment data below the national level will be removed from all publication and available data sources. In addition to the Welsh Government, WLGA and Estyn have also expressed the view that it is counterproductive for schools to be placed under disproportionate pressure on the basis of individual performance measures when discharging its statutory duties when reporting on school performance. As the surveys published within this report could be considered to be evaluating school performance, caution needs to exercised and only headline data reported, with some analysis of the most and least positive responses.
- 5.6 Where cumulative positive responses to questions are above 70% the question has been marked as green, where 50-69% of responses were positive, the question has been marked as amber, and where less than 50% of responses were positive, questions have been marked as red. The average responses quoted related to the respondents either strongly agreeing or agreeing with the statement.
- 5.7 The results of the surveys will be discussed with the headteachers of the individual schools. Where responses have highlighted a cause for concern and marked as red, senior local authority officers will provide further forums to explore these issues in greater depth with relevant stakeholders, including school leaders.
- 5.8 All respondents were given the opportunity to make additional comments as a part of the consultation exercise. These comments are not reported in this report in full as many respondents referred to their specific school or to school staff and learners by name. In order to comply with data protection legislation, only common themes are reported.

## 6. LEARNER SURVEY OUTCOMES

6.1 Table 1 details learner survey outcomes.

- 6.2 The learner survey results show that learners are largely positive about their schools across both sections of the surveys. Some questions were specific to particular age groups in order to only capture responses from learners with specific experiences. For instance, only year 7 and 8 learners were asked about transition arrangements as it is only these age groups which have experienced the transition programme since the opening of the new all through schools.
- 6.3 131 learners made use of the space at the end of the survey to make additional comments. The recurring themes of these comments are summarised below:
  - Learners commented that they like their school and/or receive good help and support from their teachers;
  - Learners also made negative comments regarding the cleanliness and day-to-day maintenance of the school toilets.
- 6.4 These results indicate that more work needs to be undertaken to understand levels of interaction between learners across phases in the different schools in order to ensure that positive relationships are being developed between them.
- 6.5 In regard to learner responses concerning school toilets, this is in part due to some of the toilets in the schools surveyed not being replaced or refurbished as part of the school reorganisation. This issue will be explored further with individual schools in the post occupancy surveys. Furthermore, as a part of the planned Education Capital Programme for 2020, there is a commitment to ensure that all existing toilets in the new schools will be remodelled to 21<sup>st</sup> Century School standards.
- 6.6 Some comments focused on the maintenance and cleanliness of the school toilets, with one school receiving a disproportionate number of comments relating to this issue. This is a management issue that senior officers in the 21<sup>st</sup> Century Schools team will raise with the schools on an individual basis in order to ensure that toilet facilities are managed more effectively in the future. Termly inspections of the toilets will be carried out at the three schools going forward to ensure that cleanliness standards are not only improved but also sustained.
- 6.7 Although 59% of upper school learners agreed that they know about all of the opportunities available to them when they leave school, RCTCBC is already seeking to improve the quality of careers advice for learners. All 22 secondary schools are taking part in The Gatsby Good Career pilot which is being delivered by RCT Employment Education and Training Team in collaboration with the Welsh Government with all schools now having a designated Career Leader. The pilot is having a very positive impact on many schools.
- 6.8 59% of learners responded positively when asked whether they use school facilities outside of school hours. However, there appears to be a need to further promote the community use of facilities through a collaborative approach involving schools and RCT's Youth Engagement and Participation Service.

6.9 Making assets available for community use where demand exists is a funding priority of the Welsh Government Band B 21<sup>st</sup> Century Schools and Colleges Programme. RCTCBC's Education and Inclusion Services will seek to realise and maximise this aspect in all future projects.

## 7. <u>STAFF SURVEYS</u>

7.1 Table 2 details the staff survey outcomes.

- 7.2 A total of 23 members of staff made use of the space provided at the end of the survey to make additional comments. The recurring themes of these comments are summarised below:
  - A recurring theme was that the all through school model has significant potential.
  - There was a mixed response to the ICT provision at the schools.
- 7.3 These results show that we need to continue to encourage staff to take the professional development opportunities available to them. This issue will be further raised with the individual school leadership teams and a solution will be sought which ensures that staff feel sufficiently supported to seek out new professional development and leadership opportunities available in the all through schools. Additionally, the Council will continue to fund the middle leadership management courses which continues to have exceptionally high attendance levels.

- 8.2 A total of 78 parents and carers made use of the space provided at the end of the survey to make additional comments. The recurring themes of these comments are summarised below:
  - The new school facilities are impressive and of a high quality;
  - Communication between schools and parents/carers needs to be improved.
- 8.3 Positive outcomes include that parents and cares understand the school attendance policy and were satisfied with the transition programme into year 7.
- 8.4 47% of parents and carers surveyed perceived that the local community is able to access school facilities outside of school hours. We believe that this is in part due to a misconception as leisure facilities that were created as part of the 21<sup>st</sup> Century Schools to create a community campus environment are not viewed as an investment in the school itself. The participation figures do not reflect the perception results received. Nevertheless, further exploration of this viewpoint would be helpful to address concerns.
- 8.5 Additionally, new 3G facilities on school sites have seen significant use since opening. Management of some of the 3G pitches has been transferred to Leisure Services and community use of the pitches is growing rapidly and in some cases fully utilised. The remaining 3G pitches are in the process of being transferred to Leisure Services to ensure that community use of these exceptional facilities are maximised.
- 8.6 As previously stated, the Education and Inclusion Service will seek to ensure increased community use of school facilities by working collaboratively with existing 21<sup>st</sup> Century Schools to make assets available for community use in line with the priorities of the Band B 21<sup>st</sup> Century Schools and Colleges Programme.
- 8.7 69% of respondents agreed that their school works with parents/carers to achieve what is best for their children. The Education and Inclusion Services will continue to work with schools to identify and overcome barriers to effective relationships between schools and parents/carers.

# 9. <u>GOVERNOR SURVEY OUTCOMES</u>

9.1 Table 4 details the governor survey outcomes.

- 9.2 6 governors made use of the space provided at the end of the survey to make additional comments. The recurring themes of these comments are summarised below:
  - The all through school model has significant potential;
  - Time is needed for schools to settle in and adapt to new ways of working.
- 9.3 It should be noted that only one of the three governing bodies surveyed returned a negative response to the question regarding financial viability and stability. It is likely to be attributable to generic concerns that governors often have in relation to financial pressures.

#### 13. LINKS TO THE COUNCILS CORPORATE PLAN/CORPORATE PRIORITIES/SIP

13.1 The Council's Corporate Plan commits to "Continue to invest in improving school buildings, to ensure the County Borough's learners have the learning environment fit for the 21st Century." The proposals delivered through the 21<sup>st</sup> Century's Schools and Colleges Programme, that are considered in this report, have taken into account the seven well-being goals and the five ways of working.

#### 14. <u>CONCLUSIONS</u>

14.1 This report provides an overview of the initial perception survey relating to the Rhondda Valleys and Tonyrefail school reorganisation. The evaluation shows that good progress is being made towards the improvement of educational outcomes, educational provision, and leadership and management at all of the new schools. These responses need to be considered alongside other school

performance outcomes in order to contribute to the self-evaluation and improvement of individual schools.

- 14.2 This report has also brought to light areas where the Education and Inclusion Services need to continue to work collaboratively with schools to ensure that facilities are managed effectively and practices and procedures are revised where necessary.
- 14.3 Focus groups will be convened with different stakeholder groups to identify key areas for development and will inform any future projects.
