**REPORT OF THE SERVICE DIRECTOR, DEMOCRATIC SERVICES AND COMMUNICATION.**

**1. PURPOSE OF REPORT**

**3. BACKGROUND**

3.1 A number of items are under consideration by the Community Liaison Committee and this report looks to provide Members with details of the current status of these items to ensure Members are kept up to date.

3.2 The report also proposes a future calendar of meetings and to seek suggestions for future possible agenda items.

**4. DEMOCRATIC SERVICES UPDATES**

4.1 [The Local Authorities \(Coronavirus\) \(Meetings\) \(Wales\) Regulations 2020](#), published at the end of April, provided the opportunity for committee functions to operate virtually. The Council subsequently took an incremental approach

to the roll out of all Council committee meetings on a virtual basis and has now held meetings of Cabinet, Council and Scrutiny Committees virtually, including the Council [AGM on 16 September](#). It is envisaged that the Council will continue with its virtual meetings for the foreseeable future

- 4.2 As the rules and regulations in relation to services provided by the Local Authority are changing rapidly with local lockdowns and firebreak lockdowns, a verbal update will be provided to members on the day in relation to services provided by the local Authority.

## 5. **BUSINESS SUPPORT GRANTS**

- 5.1 Cabinet has agreed proposals to refocus the Council's business support grants due to unprecedented circumstances this year – including establishing new funds dedicated to town centre COVID-19 recovery and flood resilience.
- 5.2 At its virtual meeting on Thursday, 24 September, Cabinet considered a report outlining proposals to review the Council's Regeneration business grants portfolio. The proposals will enable the Council to provide investment in support of businesses, in response to the economic challenges they currently face due the impact of Storm Dennis and the Coronavirus emergency
- 5.3 Eligibility for the Town Centre Maintenance Grant will now be revised to include actions that facilitate social distancing such as small scale shop/building front modifications. Currently, the grant is limited to supporting traders and landlords to undertake minor improvements to their building fronts in order to improve the street scene – in Mountain Ash, Tonypany, Treorchy, Aberdare, Ferndale and Porth. It offers a contribution of 75% up to a maximum grant of £1,000, and where necessary a contribution of 75% towards skip/scaffold costs up to a maximum of £300.

## 6. **CONSULTATIONS**

- 6.1 Current consultation exercises being carried out by the Council are a little different at the moment due to the Coronavirus pandemic – but there are still a number of ways which residents will be able to participate in the process.

There is also a dedicated phone number, email and free post address for people to have their say. There will also be an opportunity for residents to join virtual public drop-in sessions on Zoom, while an Older Persons Advisory Group session will also be held on this platform.
