"Will the Cabinet Member make a statement on Digital Inclusion?"

(2) From County Borough Councillor G.Smith to County Borough Councillor A.Morgan (Leader of the Council)

"Please could the Leader update Members on the recent landslip which took place on Maerdy Mountain?"

Response from County Borough Councillor A.Morgan

A report should be coming forward to the Cabinet for consideration in the next 4-6 weeks and hopefully this will give us an indication of what is needed and the costs involved. Work is not likely to start until mid to late Summer and could take several months to complete.

Supplementary Question from County Borough Councillor G.Smith

"Maerdy Mountain road and the Rhigos Mountain road are key routes to the Rhondda and investment is great. Can you given an update on investment on the Rhigos Mountain road."

Response from County Borough Councillor A.Morgan

"We are still planning to re-surface around 6 km of road. It is over-laying so it will be strengthening the road rather than taking up what is there. A considerable amount of drainage work needs to be done and this will be carried out in the next 4-6 weeks. We will be in a position then for the main re-surfacing work to commence during the School Holidays to limit the impact but it is likely that there will be closures on that mountain but the two mountain roads will not be closed at the same time. Any closure of the Rhigos Mountain road will be minimised."

(3) From County Borough Councillor R.B.McDonald to County Borough Councillor A.Morgan (Leader of the Council)

"Will the Leader please provide an update on the progress of the City Deal?"

Response from County Borough Councillor A.Morgan

"The progress since the last Council meeting is that 4-5 key areas of work are going forward. The first one will be establishing a Joint Cabinet (in shadow form) so a report will be coming to the Cabinet and/or Council in the future. We are also working on having a Joint Transport Authority. There is a huge amount of work going on led by Jane Cook around 'Mapping' of land use and within 4-6 weeks this will be evidence based to bring forward projects. We want to bring in private investment and have had a positive meeting around establishing a new South Wales Business Forum set up by businesses."

Supplementary Question from County Borough Councillor R.B.McDonald

"Obviously, the City Deal is a massive opportunity for RCT and no doubt, many areas could benefit. An area of particular concern for me and residents in my Ward and surrounding areas is the A4119 where it becomes a single carriageway by the Royal Glamorgan Hospital. This is the single biggest blocker for the Coed Ely development. Can you provide any assurance that this is to be improved, potentially, by the City Deal"

Response from County Borough Councillor A.Morgan

"I cannot give a categoric decision now but I think it is something that is coming up in the Mapping and something we are putting forward in our regional intentions. The A4119 is a strategic corridor. We have been trying to look at traffic light junctions by the Castell-y-Mynach to improve flows. As part of the infrastructure plan, I hope to bring to the Cabinet and Council this year that we are trying to do something around the A4119 which needs to be dualled. It may make the Coed Ely site more attractive to developers. I hope by the end of this year, we will be in a position to say it is part of the infrastructure plan coming forward for this Authority."

(4) From County Borough Councillor C.Williams to County Borough Councillor A.Morgan (Leader of the Council)

"Will the Leader make a statement on Highways Investment?"

Response from County Borough Councillor A.Morgan

"We have invested heavily in road over the last few years. Firstly, on the condition of our carriageways, we have gone from being one of the worst to now be in the top quartile in Wales. Investment is making a difference. We are spending millions on footways which helps bring down our injury claims through the good work of our inspectors, finance and legal people who try and make sure that we defend as many claims as possible. There is still a significant backlog with our structures. We have a significant number of bridges being monitored and some need complete renewal. We are making progress but there is still a long way to go."

Supplementary Question from County Borough Councillor C.Williams

"Can the Leader advise us how residents will be kept informed of any investment works in RCT?"

Response from County Borough Councillor A.Morgan

"All works that are on-going are on the Council's website. Any work on the highways is published every week. We are looking as well to promote more and more on social media so people can interact. Hopefully, this can be launched this year and it will provide information on what works are being done. I want an Investment Map which will show what is being done and what has been completed as this will help people to see what's happening."

(5) From County Borough Councillor P.Jarman to County Borough Councillor K.Montague (Cabinet Member for Tackling Poverty, Engagement and Housing)

145 <u>MEDIUM TERM SERVICE PLANNING – UPDATE</u> COUNCIL REVENUE BUDGET 2016/17

 - Senior Management Structure Savings (part year 2016/17 impact of £0.280M)
 - Council Tax Reduction Scheme Savings (£0.600M)
 - Use of £0.004M available resources initially set aside as part of the fund to support hardship requirements in relation to Home to School policy changes.

146 <u>FINANCING OF THE 21ST CENTURY SCHOOLS PROGRAMME USING PRUDENTIAL BORROWING</u>

The Group Director, Corporate & Frontline Services outlined his report which sought the Council's approval in respect of the following:

- a capital investment of £1.956m at Cymmer Infants and Junior Schools; and
- financing the refurbished school buildings through the Welsh Government's 21st Century Schools Programme (£0.978m) and from Council borrowing (£0.978m) using its powers under the Prudential Code.

Following consideration of the report, it was **RESOLVED** –

(1) To agree to the inclusion in the Capital Programme of the major cpital works at Cymmer Infants and Junior Schools at a total cost of £1.956m.

(2) To agree that the net cost to the Council of £0.978m is funded through borrowing, using the Council's powers under the Prudential Code, with the annual revenue cost of £0.048m being met from savings from this and other recent school closures and amalgamations.

- 4. To publicise the Council's concerns about TTIP; join with other local authorities which are opposed to TTIP across Europe and work with local campaigners to raise awareness about the problems of TTIP.
- 5. To contact the municipalities twinned with Rhondda Cynon Taf in Europe asking them to consider passing a similar motion on TTIP
- 6. To request the appropriate Cabinet Member to take forward these actions and for the matter and any subsequent responses and actions to be considered by the Overview and Scrutiny Committee."

- 5. To publicise the Council's concerns about TTIP; join with other local authorities which are opposed to TTIP across Europe and work with local campaigners to raise awareness about the problems of TTIP.
- 6. To contact the municipalities twinned with Rhondda Cynon Taf in Europe asking them to consider passing a similar motion on TTIP
- 7. To request the appropriate Cabinet Member to take forward these actions and for the matter and any subsequent responses and actions to be considered by the Overview and Scrutiny Committee."

150 CHIEF EXECUTIVE POST – TEMPORARY ARRANGEMENTS

In his report, the Director of Human Resources provided an update on the temporary arrangements for the Chief Executive's role and suggested that a further temporary appointment be made.

Following consideration of the report, it was **RESOLVED** –

- (1) In light of the continued uncertainty about the future of local government, the Council agrees to a further twelve month temporary appointment to the post of Chief Executive, effective from 1st September 2016.
- (2) To agree that the current temporary incumbent, Mr. Christopher Bradshaw, be offered a new twelve month temporary contract w.e.f. 1st September 2016.
- (3) That during the new temporary contract, Mr. Bradshaw continues to retain the responsibility for 21st Century Schools alongside the temporary appointment to the Chief Executive role.
- (4) To continue with the arrangement of not filling Mr. Bradshaw's substantive post and that the additional internal day to day management support that was put in place under the leadership of Mrs Esther Thomas remains during this new temporary period. Due to the recent pay award, there is a slight change to the cost of this additional temporary support, which is

based on a one grade increase within the existing Chief Officer salary structure from £14.7k to £14.9k (inclusive on on-costs)

- (5) That the Director of Legal & Democratic Services continues to undertake the temporary role of Returning Officer and Electoral Registration Officer during this time.
- (6) To note the further temporary estimated salary savings during the period of this new temporary appointments, which in line with the recent pay award have slightly increased from £132.5k to £133.8k (inclusive of oncosts) effective from 1st September 2016.
