4 RETIRING MAYOR'S REMARKS

The Retiring Mayor took the opportunity to reflect on his term of Office as Mayor of Rhondda Cynon Taf County Borough Council and the opportunities the role provided to raise aspirations for those living and working within the County Borough and the opportunity of giving young children the chance to be 'Mayor for the Moment'. Councillor Powderhill reflected on the recent awards ceremony undertaken through the 'Good Citizens' Awards and the Mayor's 'Community Awards', recognising the achievements and work of residents in the Community and providing a platform to recognise such local and exceptional talent within the County Borough.

Councillor Powderhill commented on the fundraising achieved for his 3 charities, namely `Giving to Pink`, Velindre Hospital and Welsh Hearts, and advised of other forms of support to other charities that he had driven forward over the year.

Councillor Powderhill commented on the humbling experiences he had shared over his term in office and thanked all those that had supported him in making his year a success, in particular noting the work of Ms A. Davies (secretary to the Mayor) who was retiring at the end of the month.

RESOLVED – that County Borough Councillor L De Vet be elected as Mayor of the County Borough for the 2019-2020 Municipal Year.

Following her election, the retiring Mayor presented County Borough Councillor De Vet with her chain of office.

On taking the Chair, County Borough Councillor De Vet thanked the Members for their support and confidence in electing her as Mayor of the County Borough and stated that she would undertake the role with pride and act as a good ambassador. She then paid tribute to the retiring Mayor.

Upon her appointment, the Mayor presented the Deputy Mayor with her chain of office and she was congratulated on her appointment.

The Mayor called upon Pastor B J Stagner to offer a blessing.

8 APPOINTMENT OF LEADER AND DEPUTY LEADER OF THE COUNCIL 2019- 2020.

RESOLVED – That County Borough Councillor A.Morgan be appointed Leader of the Council for the 2019 – 2020 Municipal Year and to note that County Borough Councillor M.Webber to be appointed as Deputy Leader of the Council.

County Borough Councillor A.Morgan thanked Members for supporting his appointment and spoke of the positive work accomplished and the investment in services even through austere times.

Members took the opportunity to congratulate the Leader on his appointment.

Members were advised that the Leader's Scheme of Delegation would be made available on the Council website following the meeting.

10 APPOINTMENT OF A PRESIDING MEMBER

The Service Director, Democratic Services & Communication referred Members to his report and the recommendation of the Council's Corporate Governance and Constitution Committee to appoint a Presiding Member (and Deputy Presiding Member) into the Council structure to undertake the administrative functions of the Chair of the Council as set out in Article 5 of the Council's Constitution, with such an appointment being taken forward on an annual basis, commencing from the 2019 Council Annual General Meeting.

Clarification on the role of the Presiding Member was provided with the Service Director explaining that if taken forward the ceremonial and civic functions would become a stand-alone role to be undertaken by the Mayor (or in his/her absence the Deputy Mayor).

It was added that if remunerated, a Presiding Member would be entitled to a Band 3 Senior Salary (for $19/20 \pounds 22,568$) and the post would count towards the Senior Salary cap for this Council of 19 posts.

Following a detailed discussion it was **RESOLVED** to:

- 1. Note the recommendation of the Corporate Governance & Constitution Committee to appoint a Presiding Member (and Deputy Presiding Member) on an annual basis with such appointment being made at the Annual General Meeting, commencing from the 2019 Council Annual General Meeting.
- 2. Appoint a Presiding Member (and Deputy Presiding Member) into the Council structure whom would undertake the administrative functions of the Chair of the Council for which are currently carried out by the Mayor.
- 3. Agree that the Director of Legal Services (as Monitoring Officer) amend the Council's Constitution to reflect the required amendments detailed in the above recommendations and make any consequential
- 4. Appoint County Borough Councillor S Powderhill and County Borough Councillor G Hughes as Presiding Member and Deputy Presiding Member, respectively for the 2019-2020 Municipal Year.

N.B.

- The Plaid Cymu Group Members, Alliance Group Members, Conservative Group Members and unallocated Members in attendance at the meeting wished to record that they voted against the appointment of a Presiding Member and Deputy Member role to the Council Structure.
- County Borough Councillor S Powderhill took the Chair following his appointment.

11 OVERVIEW AND SCRUTINY 'FIT FOR THE FUTURE' - PROPOSED SCRUTINY ARRANGEMENTS

The Service Director, Democratic Services & Communication provided Members with details of the proposals in response to the Wales Audit Office 'Fit for the Future' review in respect of the Council's Scrutiny arrangements and sought approval to amend the Constitution to reflect the proposals contained within the report, subject to the proposed amendments recommended by the Overview and Scrutiny Committee at its meeting on the 1st May 2019.

The Cabinet Member for Council Business spoke of the importance of all political groups having the opportunity to be represented on Scrutiny Committees, where practicable, and indicted an amendment would be proposed to the number of seats on the Scrutiny, Democratic and Audit Committee membership for 2019 – 2020 from the previous 15 to 14 to allow for greater member engagement.

It was **RESOLVED**:

- 1. To note the observations and responses to the proposals of the WAO Fit for the Future review as outlined within the report and its appendix.
- 2. To agree that following prior consultation with the Scrutiny Chairs and Vice Chairs, the Terms of Reference of each of the Scrutiny Committees be reviewed, refined and agreed by the Overview and Scrutiny

Committee at its first meeting, of the 2019-2020 Municipal Year.

- 3. To agree that authority is provided to the Director of Legal Services (as Monitoring Officer) to update the Council Constitution accordingly to reflect the changes to the Committees Terms of Reference, once agreed upon.
- 4. To agree to the further recommendations outlined within the review report, subject to the proposed amendments by the Overview and Scrutiny Committee, as highlighted within section 3.3 of the report and referenced in Appendix B.

Any questions on notice not answered will need to be resubmitted to the Proper Officer for the next full Council meeting in accordance with these rules. This rule does not prevent a Member asking an urgent question to which the Mayor has agreed can be put in accordance with Rule 9.4(b). Any such urgent questions shall be put prior to the commencement of the 20 minutes allocated for questions received on notice.

- 3(ii) For the reasons outlined in paragraph 5.12 of the report to amend Procedure Rule 9.5(c) as follows:
 - (c) where the reply cannot conveniently be given orally, a written answer

provided subsequently to the questioner, within 10 working days and a copy of the answer circulated to all Members.

- 10 That given the Independent Remuneration Panel for Wales has removed the provision for making payments to Chairs of Joint Overview and Scrutiny Committees that the Council makes an application to the Panel for a specific salary relating to the position of Chair of the Cwm Taf Public Services Board Joint Overview and Scrutiny Committee with the application being made based on a £6770 salary which is consistent with how the remuneration of the post was calculated in previous IRP reports.
- 11 That the application outlined in 10 above be reviewed on an Annual basis at the Council's Annual General meeting.
