1. PURPOSE OF THE REPORT

- 4.2 In accordance with Rule 12.2 of the Access to Information Procedure Rules (Part 4 of the Council's Constitution) the Work Programme will contain information in respect of the timetable for considering the budget and any plans forming part of the policy framework and requiring Council approval.
- 4.3 During the period outlined, the Work Programme may be subject to further change to take into account any additional/deleted reports, including any new consultative documents or legislative initiatives from the Welsh Government, which require urgent attention.
- 4.4 The Work Programme will also assist Members if any items have been referred to a Committee or service area for consideration / action and relevant updates are required by Council (e.g. Action required in respect of a Notice of Motion considered by Council).
- 4.5 A draft Work Programme is attached as Appendix 1 to this report for Members' comment.
- 4.6 Subject to agreement, a link to the agreed work programme will be added to every Council meeting agenda for Members information, to allow Members to be kept updated on any amendments to the programme going forward.

5.1 The Work Programme has been compiled by members of the Senior Leadership Team in discussion with the Chair.
