- 2.4 To nominate a Member from the Labour Group to sit on the Cwm Taf Community Health Council in place of County Borough Councillor J Bonetto for the remainder of the term.
- 2.5 Subject to the agreement of 2.4, correspondence be sent to the Cwm Taf Community Health Council advising them of the Authority's nominated representative to the Community Health Council.
