To consider the under-mentioned Notice of Motion standing in the names of County Borough Councillors J Bonetto and G Holmes:

Rhondda Cynon Taf County Borough Council calls on the UK Government to provide sector-specific funding to the UK's aviation industry in order to protect high-value skills and jobs in RCT and across Wales and the UK into the future.

We urge the UK Government to provide funding levels commensurate to the aviation sector's strategic importance and to do so urgently, in order to help the sector through this difficult period and to prevent job and skills losses at General Electric in Nantgarw, British Airways in Llantrisant and other aviation sites across Wales and the UK; in addition to the thousands of jobs in the wider supply chain.

We believe that the aviation sector has a bright future and that if the UK Government fails to act it will not only have devastating economic and social impact on the affected communities, but the loss of high-skilled jobs will put the UK's aviation industry at a competitive disadvantage when the recovery begins.

Any investment package must, however, also take in to account climate

change and carbon emissions, and the stimulus must provide the necessary funding for the development of technology to reduce the carbon footprint of our aviation industry.

We welcome the support provided by Welsh Government and call on Welsh Government Ministers to continue to press UK Government Ministers to recognise the special position of the aviation sector and to act to protect jobs and skills for the future.
