63 INTRODUCTION AND PROCEDURE

The Chair welcomed everyone to the special meeting of the Committee and for the benefit of those members of the public in attendance she called on the Director of Legal and Democratic Services to explain the Call-in procedure.

The Director explained the process and purpose of the Call-in. He outlined the composition of the Committee which included co-opted Members and explained that those Members who had instigated the call-in were also in attendance to outline their reasons for calling-in the Cabinet decision taken on the 12th February, 2014 in respect of – Medium Term Service Planning – School Admission Arrangements – Funding for Nursery Provision; Councillor Jarman who was one of the three signatories to the call-in is a Member of the Committee and would therefore be able to vote on the matter. He also pointed out that the Leader of the Council and the Cabinet Member with responsibility for Education, Skills & Lifelong Learning together with the Cabinet Member for Corporate Affairs & Council Business and the Cabinet Member for Children's Social Services & Equalities along with the appropriate Officers were also in attendance to make comment or answer any questions of the Committee.

The Director of Legal and Democratic Services explained that before commencing the debate, it was important to agree the procedure to be adopted and he drew Members' attention to pages 1 and 2 of the report which outlined the recommended procedure to be followed and the issues to be taken into account in considering the decision taken by Cabinet on the 12th February, 2015.

Members were advised of the information before them, namely:-

- Appendix A Copy of the report presented to Cabinet on the 12th February, 2015.
- Appendix B The Decision Notice of Cabinet.
- Appendix C Extract from the Council's Constitution of Scrutiny Procedure Rules re: Call-in.
- Appendix D Copy of prescribed Call-in form.

The Director of Legal and Democratic Services briefly highlighted to the Committee the changes to the Call-in provisions following the Council's Annual Meeting in May, 2014 and clarified that two of the three Members who had instigated the Call-in were not Members of the Committee and that Councillor Jarman who was a signatory to the Call-in was a Member of the Committee and could therefore vote on the matter. The Director of Legal and Democratic Services continued by outlining the reasons given by the three Members in requesting the Call in, at Appendix D and which were reproduced in paragraph 2.7 of his report. He referred to paragraph 2.8 of the report which proposed that one of the three Members be given the right to make a final address to the Committee immediately before a vote is taken on the proposal and also explained that if the proposal to have the matter referred back to Cabinet was unsuccessful, then the Cabinet decision would take effect from the date of the meeting i.e. 24th February, 2015.

RESOLVED – to adopt the procedure as set out in paragraphs 2.7 and 2.8 of the report.
