Summary report

Introduction

- 1. The Auditor General is responsible for providing an opinion on whether the financial statements give a true and fair view of the financial position of Llwydcoed Crematorium Joint Committee (the Joint Committee) at 31 March 2015 and its income and expenditure for the year then ended.
- 2. We do not try to obtain absolute assurance that the financial statements are correctly stated, but adopt the concept of materiality. In planning and conducting the audit, we seek to identify material misstatements in your financial statements, namely, those that might result in a reader of the accounts being misled.
- 3. The quantitative levels at which we judge such misstatements to be material for the Joint Committee is £8,604. Whether an item is judged to be material can also be affected by certain qualitative issues such as legal and regulatory requirements and political sensitivity.
- **4.** International Standard on Auditing (ISA) 260 requires us to report certain matters arising from the audit of the financial statements to those charged with governance of a body in sufficient time to enable appropriate action.
- 5. This report sets out for consideration the matters arising from the audit of the financial statements of the Joint Committee for 2014-15, that require reporting under ISA 260.

Status of the audit

- **6.** We received the draft financial statements for the year ended 31 March 2015 on 9 June 2015 well ahead of the submission deadline of 30 June 2015 and have now substantially completed the audit work.
- 7. We are reporting to you the more significant issues arising from the audit, which we believe you must consider prior to approval of the financial statements. The audit team has already discussed these issues with the Joint Committee accountant and the Head of Education and Financial Reporting.

Proposed audit report

- 8. It is the Auditor General's intention to issue an unqualified audit report on the financial statements once you have provided us with a Letter of Representation based on that set out in Appendix 1.
- **9.** The proposed audit report is set out in Appendix 2.

Significant issues arising from the audit

Uncorrected misstatements

10. There are no misstatements identified in the financial statements, which remain uncorrected.

Corrected misstatements

11. There are misstatements that have been corrected by management, but which we consider should be drawn to your attention due to their relevance to your responsibilities over the financial reporting process. They are set out with explanations below.

N/A	A disclosure note added to explain that support services are provided by the host Council and that the remuneration of those senior staff is shown in the host body accounts.	To comply with disclosure requirements of the Code.

Other significant issues arising from the audit

- 12. In the course of the audit, we consider a number of matters both qualitative and quantitative relating to the accounts and report any significant issues arising to you. There were no issues arising in these areas this year:
 - We have no concerns about the qualitative aspects of your accounting practices and financial reporting. We found the information provided to be relevant, reliable, comparable, material and easy to understand. We concluded that accounting policies and estimates are appropriate and financial statement disclosures unbiased, fair and clear.
 - We did not encounter any significant difficulties during the audit. We received information in a timely and helpful manner and were not restricted in our work.

- There were no significant matters discussed and corresponded upon with management which we need to report to you. We note however the accounts do not recognise costs for time incurred by one officer for a period following the departure of the previous registrar as no records were kept. We are satisfied that this amount is not material. Whilst the budget includes a portion of costs in 2015-16 we recommend that records are maintained that enable an accurate charge to be recognised in the accounts.
- There is one matter significant to the oversight of the financial reporting process that we need to report to you. We note the Joint Committee does not receive internal audit reports for information and consideration. We recommend the Joint Committee receives internal audit reports on crematorium activities to maintain effective oversight of financial management and reporting.
- We did not identify any material weaknesses in your internal controls that we have not reported to you already.
- There are no other matters specifically required by auditing standards to be communicated to those charged with governance.

Independence and objectivity

- **13.** As part of the finalisation process, we are required to provide you with representations concerning our independence.
- **14.** We have complied with ethical standards and in our professional judgment, we are independent and our objectivity is not compromised. There are no relationships between the Wales Audit Office and the Joint Committee that we consider to bear on our objectivity and independence.

The financial statements are free of material misstatements, including omissions. There were no uncorrected misstatements identified.

Proposed audit report of the Auditor General to the members of the Llwydcoed Crematorium Joint Committee

I have audited the accounting statements and related notes of Llwydcoed Crematorium Joint Committee for the year ended 31 March 2014 under the Public Audit (Wales) Act 2004.

Llwydcoed Crematorium Joint Committee accounting statements comprise the Movement in Reserves Statement, the Comprehensive Income and Expenditure Statement, the Balance Sheet and the Cash Flow Statement.

The financial reporting framework that has been applied in their preparation is applicable law and the Code of Practice on Local Authority Accounting in the United Kingdom 2014-15 based on International Financial Reporting Standards (IFRSs).

Respective responsibilities of the responsible financial officer and the Auditor General for Wales

As explained more fully in the Statement of Responsibilities for the Statement of Accounts set out on page 6, the responsible financial officer is responsible for the preparation of the statement of accounts, which gives a true and fair view.

My responsibility is to audit the accounting statements and related notes in accordance with applicable law and International Standards on Auditing (UK and Ireland). Those standards require me to comply with the Financial Reporting Council's Ethical Standards for Auditors.

Scope of the audit of the accounting statements

An audit involves obtaining evidence about the amounts and disclosures in the accounting statements and related notes sufficient to give reasonable assurance that the accounting statements and related notes are free from material misstatement, whether caused by fraud or error. This includes an assessment of: whether the accounting policies are appropriate to the Llwydcoed Crematorium Joint Committee's circumstances and have been consistently applied and adequately disclosed; the reasonableness of significant accounting estimates made by the responsible financial officer and the overall presentation of the accounting statements and related notes.

In addition, I read all the financial and non-financial information in the Foreword to identify material inconsistencies with the audited accounting statements and related notes and to identify any information that is apparently materially incorrect based on, or materially inconsistent with, the knowledge acquired by me in the course of performing the audit. If I become aware of any apparent material misstatements or inconsistencies, I consider the implications for my report.
