	The applicant has no control over the existing sub-standard access leading to the proposed development site and therefore the existing access to Gadlys Uchaf cannot be improved to provide a safe and satisfactory access.	
	The proposal removes the existing car parking available for number 6 Gadlys Uchaf, resulting in addition on-street parking in an area where there is already substantial demand, to the detriment of highway safet

Proposal:	Four bed detached house and garage with parking.

Reason: 1	The development by reason of its siting, size, scale and design would have an adverse effect on the visual appearance of the area as a whole. As such the development would be contrary to Policies AW5, AW6 and AW7 of the Rhondda Cynon Taf Local Development Plan.
Reason: 2	The development would neither enhance an existing public right of way nor replace it with one that would provide an equivalent or greater provision. As such the development is contrary Policy AW7 of the Rhondda Cynon Taf Local Development Plan.
Reason: 3	The proposal would result in a loss of amenity to a dwelling permitted in planning permission reference 12/1165/15 as a result of overlooking from habitable main windows. As such the development would be contrary to Policy AW 5 of the Rhondda Cynon Taf Local Development Plan.
Reason: 4	Insufficient information has been submitted to enable the Local Planning Authority to assess the ecological impact of the proposal. As such the development would be contrary to Policy AW 8 of the Rhondda Cynon Taf Local Development Plan.
Reason: 5	The proposal is piecemeal that would prejudice the delivery of a more comprehensive development which does not reflect the previous approval for residential development on Bodwenarth Farm to the detriment of the safety of all highway users and free flow of traffic. As such the development would be contrary to Policy AW 5 of the Rhondda Cynon Taf Local Development Plan.
	In the absence of adequate turning facilities to cater for calling delivery and emergency vehicles, the proposal would result in vehicular reversing movements to and from Albion Court creating traffic hazards to the detriment of the safety of all highway users and free flow of traffic. As such the development would be contrary to Policy AW 5 of the Rhondda Cynon Taf Local Development Plan.
	The proposed access lacks adequate visibility for vehicles emerging from the site, which will create hazards to the detriment of highway safety. As such the development would be contrary to Policy AW 5 of the Rhondda Cynon Taf Local Development Plan.
