The Applicant Mr David Williams exercised the right to respond to the comments made by the objectors.

Non-Committee/ Local Members – County Borough Councillors G Thomas and K Morgan spoke on the application and put forward their objections in respect of the proposed Development.

The Head of Major Development and Investment provided Members with an

update on the number of objections received to date in comparison to the number provided in the original report.

He also informed members there were no further implications to consider in respect of the recently published Future Wales 2040 Framework and Planning Policy Wales 11.

The Head of Major Development and Investment continued by showing Members drone footage of the site and then proceeded to give Members a presentation on the application.

Following lengthy discussion Members were minded to refuse the above-mentioned application contrary to the recommendation of the Director, Prosperity & Development as Members were of the view that the application would be an incongruous and inappropriate development which would have an adverse, detrimental and unacceptable visual impact on the landscape and compromise the visual amenity. Therefore, the matter would be deferred to the next appropriate meeting of the Planning & Development Committee for a report of the Director, Prosperity & Development, if necessary in consultation with the Director, Legal Services, highlighting the potential strengths and weaknesses of making a decision contrary to the recommendation of an officer or any proposed or possible planning reason for such a decision prior to determining a matter.
