Development of the Cwm Taf Community Safety Delivery Plan 2018-21

#### 1. PURPOSE OF THE REPORT

To update elected members about the development of the Cwm Taf Community Safety Delivery Plan 2018-21 and the proposed arrangements for monitoring progress. The Plan seeks to ensure the Cwm Taf Community Safety Partnership is accountable for the delivery of actions in response to the priorities identified by the Cwm Taf Community Safety Needs Assessment 2017 (Draft) undertaken by the Community Safety Board on behalf of the Public Services Board.

#### 2. **RECOMMENDATIONS**

It is recommended that members:

- 2.1 Scrutinise the progress made with developing the Cwm Taf Community Safety Delivery Plan 2018-21;
- 2.2 Scrutinise and comment on the proposed Key Actions identified in the Cwm Taf Community Safety Delivery Plan 2018-21.

#### 3. BACKGROUND

3.1 On the 26<sup>th</sup> October 2017, the Communities and Prosperity- Crime and Disorder Scrutiny Committee received a report and scrutinised the findings of the Cwm Taf Community Safety Strategic Assessment (Draft) prepared by the Cwm Taf Community Safety Board. The Assessment was undertaken to review existing service provision and delivery within Cwm Taf, determine objectives following analysis of current issues in our

- communities and key strategic influences including the Public Service Board, Police and Crime Reduction Plan and broad community engagement programmes.
- 3.2 The Cwm Taf Community Safety Board is now required by the Crime and Disorder Act 1998 (as amended) to develop a strategy for the reduction of crime and disorder in the area, including anti-social behaviour and other behaviour adversely affecting the local environment. At its meeting on the 16<sup>th</sup> November 2017, the Cwm Taf Community Safety Board resolved to accept the findings and strategic priorities identified by the Cwm Taf Community Safety Needs Assessment 2017 (Draft) and move forward to develop the Cwm Taf Community Safety Delivery Plan 2018-21. This will constitute the three year strategic plan to reduce crime and disorder in our communities.
- 3.3 The six Priority Areas to be included in the Delivery Plan are:
  - A. Reduce the impact of alcohol and drug misuse on our communities.
  - B. Divert offenders and reducing re- offending
  - C. Tackle Violence against Women, Domestic Abuse and Sexual Violence
  - D. Promote Safe and Confident Communities
  - E. Protect vulnerable groups from harm and victimisation
  - F. Improve the environment by reducing environmental crime

In addition, a Cross Cutting Priority to "Improve Communication and Engagement with our Communities" has been identified and will be a common and recurring theme for all of the Community Safety Priorities.

3.4 In order to facilitate the development of the Delivery Plan, the Cwm Taf Community Safety Board established a "Task and Finish" Group to comprise representatives of all organisations that are members of the Board and other organisations that make a significant contribution to the strategic priorities identified by the Assessment.

#### **Development of the Delivery Plan**

- 3.5 The "Task and Finish" Group was established in January 2018. The first meeting of the Group sought to agree the principles that would inform the Plan development and arrangements for monitoring and measuring progress against the Priorities of the Cwm Taf Community Safety Assessment. These Principles were:
  - There will be clear synergy with other Strategic Plans that contribute to delivery of the Community Safety Priorities. This includes the Substance Misuse Plan, VAWDASV Plan (Violence against Women, Domestic Abuse and Sexual Violence), Youth Justice Plan and the Safeguarding Plans. These plans are already based on evidence within the Community Safety Assessment. Ensuring these plans fit together in the wider Delivery Plan will ensure coherence of approach and avoid duplication by partners.
  - ii) The actions in the Delivery Plan will be based on the evidence from the Assessment and be actions that drive improvement.

This will ensure the Delivery Plan is focused on addressing the needs of our communities and builds on the work already being done by single agencies or as part of existing core (business as usual) activities.

- iii) Actions will require a partnership approach and accountability for delivery of all actions will be to a named Partnership Group within the Cwm Taf Partnership Landscape. This will ensure clear governance through partnership arrangements and accountability back to the Cwm Taf Community Safety Board and ultimately the Public Services Board.
- Monitoring of progress against the Delivery Plan will be to the Community Safety Board on a quarterly basis, with Partnerships reporting by exception i.e. where actions are complete/ exceed targets set or where actions are not on target. This will minimise the burden on partners to produce onerous monitoring reports but ensures a mechanism exists to highlight good practice and outputs as they are achieved. It also ensures a route to escalate problems with delivering actions so the Board can intervene to resolve.
- v) The Delivery Plan will aim to measure success through a single performance indicator, namely that "people living in Cwm Taf tell us they feel safe in their communities". Fear of crime levels reported by residents has increased with 69.4% of residents (2017) reporting they feel safe in their communities, down from 82.8% in 2014/15. Existing performance frameworks (qualitative and quantitative) will be used to monitor progress against key actions and to ensure we are "turning the curve" in ensuring a higher proportion of our population feel that Cwm Taf is a safe place to live.

#### **Progress and next steps**

- 3.6 The "Task and Finish" Group has met twice and has prepared a Draft Delivery Plan. All key priorities identified in the Assessment have appropriate actions identified that aim to reduce crime and disorder in Cwm Taf. A performance framework is being built as part of the Delivery Plan to ensure we monitor progress against the priorities.
- 3.7 Appendix 1 of the report outlines the Key Actions under each of the six Priorities that have been identified from the Assessment and through the work of the Group. In addition, Members will receive and have an opportunity to scrutinise a detailed presentation at Committee which will outline the critical milestones (specific activities) that are being developed to ensure these key actions will be delivered by the Partnership over the next three years.
- 3.8 Having regard to the Cwm Taf Community Safety Partnership Landscape, the governance and accountability for some actions within the Plan is currently unclear. The Cwm Taf Community Safety Board has therefore identified a need to review the Delivery Plan in the context of the current Partnership Arrangements and identify where there is a need to strengthen

governance and wider commitment to partnership working. This may require a further review of the Community Safety Partnership arrangements for some priorities and actions, such as environmental crime and homelessness prevention, to ensure these are adequately supported by all partners. The Cwm Taf Community Safety Board will meet in March 2018 to undertake a review of the Draft Delivery Plan and the Partnership Landscape.

#### 5. CONCLUSION

5.1 A detailed Community Safety Needs Assessment has been undertaken by the Cwm Taf Community Safety Board. The responsible Authorities are under an obligation from the Crime and Disorder Act 1998 (as amended) to produce a Strategy to address the issues identified in the Assessment and this is being developed as the Cwm Taf Community Safety Delivery Plan for 2018-2021. Progress in developing this Plan has been positive since January 2018 and the aim is to complete this plan by the end of March 2018.
