Following consideration of the Ombudsman's report, it was **RESOLVED** that County Borough Councillor K.Privett as the person who is the subject of the investigation, should be given the opportunity to make representations either, orally or in writing, in respect of the findings of the investigation and any allegation that he has failed or may have failed to comply with the Code of Conduct.
