Dear Parliamentary/Senedd Representatives,

RE: Notice of Motion in support of the Guarantee Our Essentials Campaign

At the last meeting of Full Council, Members of Rhondda Cynon Taf Council supported a Notice of Motion requesting that I write to you to express this Council's support for Trussell and Joseph Rowntree Foundation's 'Guarantee our Essentials' campaign, as supported by the Taff Ely Foodbank in RCT.

Across Rhondda Cynon Taf, over 16,634 emergency food parcels were provided to people facing hardship between April 2024 and March 2025, with 5,793 of these provided for children. Whilst this figure represents a 7.7% decrease in the number of emergency food parcels distributed since the new UK Labour Government took office, many residents are still struggling to make ends meet.

As a local authority, we recognise that some positive progress has been made by the new UK Government, alongside the Welsh Labour Government towards ending mass reliance on foodbanks. From the UK Government's commitment in the autumn budget to reducing Universal Credit debt repayment deductions from 25% to 15%, to the Welsh Government's delivery of free breakfasts for all primary school pupils, we recognise the clear drive to support families and low-income households.

However, research by the Taff Ely Foodbank, Trussell and Joseph Rowntree Foundation through their 'Guarantee our Essentials' campaign continues to present the case that Universal Credit is failing to keep people out of deep poverty, with benefits often falling well below what's needed to afford essentials.

Councils across Wales continue to play a vital role, in partnership with local organisations, to tackle food insecurity, and promote dignity in access to food. However, members of this Council remain of the view that all residents should be able to afford the essentials such as food, heating, and basic hygiene.

Therefore, we acknowledge the merits of the Guarantee our Essentials campaign and request that as a Member of the Senedd/Parliament that represents communities within our County Borough, you support the position outlined in the Motion and advocate for meaningful change in line with the ambitions of the campaign.
