Our town centres are a focus for our communities as places to live, work and shop. We need to help create the right environment and promote our area as an attractive location to live, invest and do business. To do this will mean working with stakeholders, investors and funding organisations to support improvement in our towns. Supporting business to start up, grow and win contracts is a key part of this

Why we agreed this priority

- The majority of actions within the 2012/13 priority plan have been completed although, as a result of the challenging economic times and changing policy context we are extending our deadline on the review of the action plan to deliver the Economic Regeneration Strategy
- Welsh Government state in their Programme for Government, that jobs and the economy are their overriding priority. Improving the business environment is one of the key principles guiding their approach, including support for small firms and maximising the benefits of European funding. They also support adoption of the community benefits approach to maximise the value delivered through Government procured expenditure
- In the Welsh Index of Multiple Deprivation (WIMD) 2011 Rhondda Cynon Taf was rated the third most deprived Local Authority in Wales. Rhondda Cynon Taf is noticeably more deprived than the median rank for Wales for employment, education, income, community safety and housing. In September 2011, 45,000 people of working age in Rhondda Cynon Taf were economically inactive, a rate of 30.3%. This figure is higher than that for Wales (27.5%) and for Great Britain (23.9%). Supporting local businesses and investment is key to improving employment and prosperity in the area
- The regeneration of Pontypridd and Aberdare town centres offers a real opportunity to create the best environment in order to increase levels of business investment and employment, attract more visitors and shoppers and be a focus for community events and activities. This will lead to the town centres becoming vibrant, prosperous, safe and attractive places which are sustainable into the future
