| 14 | Pupils are worried about mental health issues as Mountain Ash Comprehensive School is a safe space for them and they know their teachers. | This was bought up by the staff at Mountain Ash Comprehensive School and everyone feels the impact of change differently. |
| | | Those who suffer with anxiety will feel stress more than others. Should the proposal proceed, effective transition will be crucial in managing any change. Where this has happened before the transition process has been well managed and support where needed will be given to all pupils. |

Mountain Ash Comprehensive School pupils want to get a career and concerned that pupils will end up in dead end jobs simply because their option of staying at | This is understandable, and we note your concern. We really hope that this won't happen and both schools will do all they can to support students with the changes. |

| 26 | What is your opinion whether it should be closed? | We are here to find out your opinions so that we can have all the information. We use the factual information in our consultation information but what it doesn't include is what you all think and you are the heart of the school so your opinions really matter. This is why you have to put your comments in writing, in the same way as parents/carers and staff. |
