Residential Care Home is a home where older people live to get care and extra help if they find it difficult to live on their own.



- Keep the Council's [Care Homes](#) the same in Trealaw, Pentre, Trecynon, Hawthorn and Talbot Green.
- Build new [accommodation](#) in Treorchy.
- Build new [accommodation](#) in Ferndale.
- Build new [accommodation](#) in Mountain Ash.
- Build new [accommodation](#) in Church Village.



Accommodation is a room or building in which someone may live or stay.



Focusing on a person's choice and wellbeing, these help to keep people feeling independent with support, in their local communities.


