Cardiff Road - Proposed Parking Review 2019

As you may be aware, a review of parking and waiting restrictions in various roads Aberdare has been conducted and the Council have drawn up proposed amendments where it is possible to provide legal and safe parking places on the public highway. Waiting Restrictions (yellow lines) may also be introduced to comply with the safety of the proposal.

Only letters of support were received from Cardiff Road however, one suggestion for traffic calming measures was considered but outside the remit of this proposal.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have.
