Proposed No Waiting at Any Time (Double Yellow Lines) Aneurin Bevan Drive, Church Village

As you may be aware, the council recently consulted on proposals to introduce waiting restrictions (double yellow lines) in Aneurin Bevan Drive, Church Village to address concerns regarding obstructive parking.

15 letters were sent out and 7 responses received.

A main concern raised was that, if the restrictions were introduced as proposed, parking would be displaced to outside of the residential properties.

In view of the comments received, a revised scheme has been developed to address these concerns. It should be noted that the area directly fronting the residential properties will be free of any restrictions. This would allow residents to continue to be able to park across their driveways however; any obstructive parking would have to be dealt with by the police.

Details of the proposals are shown on the attached drawing 101-2. You may also wish to view the proposals at www.rctcbc.gov.uk/traffic

I shall be pleased to receive your observations on these proposals. For your convenience, a pro forma and postage paid addressed envelope is enclosed. Alternatively you may wish to respond by e-mail to trafficservices@rctcbc.gov.uk Responses should be returned with your observations by 27 February 2019. If I do not hear from you by that date, I shall assume that you have no comment to make on the proposals.

Your comments are important to us and will help the Council in its decision making process. Any comments received will help us decide whether to make changes to the proposals and all observations relating to the scheme will be taken into consideration, however the Council will make no formal response to your comments at this stage.
