Dear Sir / Madam,

Following the removal of the traffic splitter islands, the opportunity has been taken to review the existing parking restrictions (double yellow lines) in John Street and Park View Terrace, Abercwmboi.

The review has identified four areas where it is considered that the waiting restrictions could be removed or reduced in length without compromising road safety or impacting on traffic flow.

Details of the proposals are shown on the attached drawing T2018/124/1.

The next stage in the process is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 6 December 2018, to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk
