DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn cynnig gwneud Gormhyd o dan Adrannau 1, 2 a 4 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a'r effaith fydd:

1. Cyflwyno Gwaharddiadau Aros Ar Unrhwy Adeg ar y rhannau canlynol o'r ffyrdd:

1. Gorsaf Fysiau Tonysguboriau

- a. Ochr y gogledd-orllewin ac ochr y gogledd-ddwyrain, o'i chyffordd â Heol Cwm Elái, am bellter o 50 metr i gyfeiriad y dwyrain yn gyffredinol

2. Gorsaf Fysiau Pontypridd

- a. O ochr ogleddol ei chyffordd ogleddol â Heol System Gylchu'r Orsaf Fysiau, tua'r gogledd-ddwyrain a'r de-orllewin am bellter o 25 metr
- b. O ochr ddeheuol ei chyffordd ogleddol â Heol System Gylchu'r Orsaf Fysiau, tua'r de-orllewin am bellter o 45 metr.
- c. O ochr ddeheuol ei chyffordd â Heol System Gylchu'r Orsaf Fysiau, tua'r dwyrain am bellter o 8 metr.

3. Gorsaf Fysiau Aberdâr

- a. Yr ochr ogledd-ddwyreiniol, o ochr ogleddol ei chyffordd â Duke Street, tua'r dwyrain a thua'r de-orllewin am bellter o 105 metr

4. Gorsaf Fysiau Tonypandy (yr heol ddienw rhwng Heol Berw a Court Street, Tonypandy)

- a. Yr Ochr Orllewinol - o'i chyffordd â Court Street, tua'r gogledd-orllewin am 8 metr
- b. Yr Ochr Ddwyreiniol - o'i chyffordd â Court Street, tua'r gogledd-orllewin am 5 metr
- c. Yr Ochr Ddwyreiniol - o bwynt 21 metr i'r gogledd-orllewin o'i chyffordd â Court Street, tua'r gogledd-orllewin am 9 metr.

5. Court Street, Tonypandy

- a. Yr Ochr Ogledol - o'i chyffordd â Heol Llwynypia tua'r gorllewin o'i chyffordd â'r heol ddienw rhwng Heol Berw a Court Street, am bellter o 11 metr.

6. Heol Llwynypia, Tonypandy

- a. Ochr orllewinol Heol Llwynypia o'i chyffordd â Court Street i'r gogledd i fodloni'r cyfyngiadau presennol, sef bellter o 25 metr.

(WAITING RESTRICTIONS) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be to

1. To introduce Prohibition of Waiting At Any Time on the following lengths of roads:

1. Talbot Green Bus Station

- a. North western and north eastern side, from its junction with Ely Valley Road, for a distance of 50 metres in a generally eastward direction

2. Pontypridd Bus Station

- a. From the northern side of its northern junction with the Bus Station Gyrotary Road, north eastwards and south westwards for a distance of 25 metres
- b. From the southern side of its northern junction with the Bus Station Gyrotary Road, south westwards for a distance of 45 metres
- c. From the southern side of its junction with the Bus Station Gyrotary Road, generally eastwards for a distance of 9 metres

3. Aberdare Bus Station

- a. North eastern side, from the northern side of its junction with Duke Street, eastwards and south eastwards for a distance of 105 metres

4. Tonypandy Bus Station (the Unnamed Road between Berw Road and Court Street, Tonypandy)

- a. Western Side – from its junction with Court Street, north westwards for a distance of 8 metres
- b. Eastern Side – from its junction with Court Street, north westwards for a distance of 5 metres
- c. Eastern Side – from a point 21 metres north west of its junction with Court Street, north westwards for a distance of 9 metres

5. Court Street Tonypandy

- a. Northern side, from its junction with Llwynypia Road westwards to its junction with the Unnamed Road between Berw Road and Court Street, a distance of 11 metres

6. Llwynypia Road, Tonypandy

- a. The western side of Llwynypia Road from its junction with Court Street northwards to meet existing restrictions, a distance of 25 metres.
