PONTYCLUN SAFE ROUTES IN THE COMMUNITY

As you may be aware, the council recently consulted on proposals to introduce a 20mph speed limit in Cowbridge Road between its junctions with Park Crescent and Station Terrace and include the side roads in between.

It is also proposed to introduce School Keep Clear markings on Heol Y Felin and relocate the existing north bound bus stop from outside the Tesco store to the existing layby outside the Masonic Hall.

586 letters were delivered and 103 responses received. Of those responses;

10 objected to the scheme;

5 objected to the 20mph limit

25 objected to the re-location of the bus stop.

The main concern regarded the proposed relocation of the bus stop. While these concerns are noted, the existing arrangement causes difficulty for those using the wanting to use the service and complaints have been made of buses failing to stop and passengers not being able to board.. Therefore it is considered that relocating the bus stop would better serve the community. A shelter will be provided at the bus stop.

It is also proposed to extend the 20mph speed limit northwards to include Station Approach which is well used by pedestrians, in the 20mph limit.

It is also proposed to move the pedestrian refuge at the southern end of Cowbridge Road northwards by approximately 40 metres however this will also require the introduction of No Waiting at Any time restrictions to allow traffic to pass freely

Details of the proposals are shown on the attached drawings P095-75-003 and P095-75-004

The next stage in the process is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have. If you wish to object to the proposals, you should do so in writing by 19 February 2019 to the Traffic Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at trafficservices@rctcbc.gov.uk

Mae'n bosibl eich bod chi eisoes yn gwybod bod y Cyngor wedi ymgynghori ar gynigion i gyflwyno terfyn cyflymder o 20mya ar Heol y Bontfaen rhwng ei chyffyrdd â Chilgant y Parc a Theras yr Orsaf a chynnwys ffurdd ochr rhwng ddyn nhw.
