Mae angen y cyfyngiad fel bydd modd cynnal gwaith ar y ffordd neu yn ei hymyl.

Mae disgwyl bydd y ffordd ar gau o 19 Awst tan 25 Awst 2019 neu hyd nes bydd y gwaith wedi'i gwblhau.



**(TEMPORARY ROAD CLOSURE) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Heol-Y-Sarn, Llantrisant, from a point 23 metres north west of its junction with Gwaunruperra Road, north westwards for 65 metres

The restriction is necessary to enable works to be executed on or near the road

The closure is expected to be in operation from 19th August to 25th August 2019 or until such time as the works have been completed


**Alternative route** – from the southern side of the closure, proceed via Heol-Y-Sarn, High Street, Talbot Road, A4119, Ynysmaerdy Roundabout, Llantrisant Business Park Access Road, Common Road and Heol-Y-Sarn to the northern side of the closure

For vehicles travelling in the opposite direction, reverse the directions given above.

Access for emergency services **WILL NOT** be maintained

Access for pedestrians and residents vehicles will be maintained
