

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close the A4233 Porth, from its junction with the A4058 Cymmer road, northwards for 770 metres

The restriction is necessary to enable works to be executed on or near the road

The closure is expected to be in operation overnight between 20:00 hours – 6:00 hours on the following dates or until such time as the works have been completed

- 28th August and 29th August 2019
- 29th August and 30th August 2019


Alternative route – from the northern side of the closure, proceed via A4233 Porth Relief Road, Llanwonno Road, Aberrhondda Road, Rheola Road, Porth Street, North Road, Pontypridd Road, Cymmer Bridge and Porth Relief Road to the southern side of the closure

From the southern side of the closure, proceed via Porth Relief Road, Cymmer Bridge, Porth Street, Rheola Road, Aberrhondda Road, Llanwonno Road and A4233 Porth

Relief Road to the northern side of the closure.

Access will be maintained for pedestrians and emergency service vehicles
